CHAIR'S UPDATE

Over the last few months, the Board held public hearings on two substantive rulemaking proposals. Two of the hearings concerned a proposal filed by the Illinois Environmental Regulatory Group (IERG) to amend the Board's air pollution rules. Another hearing addressed a proposal filed by the Illinois Environmental Protection Agency (IEPA) to amend the Board's groundwater quality rules. I highlight these rulemakings below.

IERG proposes that the Board amend its air pollution regulations at Part 203 (Major Stationary Sources Construction and Modification), Part 204 (Prevention of Significant Deterioration), and Part 232 (Toxic Air Contaminants). *See* 35 Ill. Adm. Code 203, 204, 232. IERG maintains that the proposed amendments are primarily aimed at making the Board's nonattainment new source review (NA NSR) regulations consistent with the text of the federal NA NSR regulations.

IERG's proposal was the subject of Board hearings held on February 17 and April 7, 2022. The deadline for filing post-hearing public comments is May 16, 2022, and no additional hearings are currently scheduled. Participants in this proceeding to date have included IEPA and the Illinois Attorney General's Office. The rulemaking, which has not proceeded to first notice, is captioned <u>Amendments to 35 Ill. Adm. Code Part 203: Major Stationary Sources Construction and Modification, 35 Ill. Adm. Code Part 204:</u> Prevention of Significant Deterioration, and Part 232: Toxic Air Contaminants, docket R22-17.

In the other rulemaking, IEPA proposes that the Board amend its groundwater quality regulations (35 Ill. Adm. Code 620). With this rulemaking proposal, IEPA explains that it seeks to uphold the policy of the Illinois Groundwater Protection Act "to restore, protect, and enhance the groundwaters of the State, as a natural and public resource." 415 ILCS 55/2(b). According to IEPA, the proposed rule changes are designed to keep Illinois' standards "current as scientific data and methods supporting the development of groundwater quality standards have evolved." Among other amendments, IEPA proposes groundwater quality standards for six Per- and Polyfluoroalkyl Substances or "PFAS."

IEPA's proposal was the subject of a Board hearing held on March 9, 2022. A second hearing is scheduled for June 21, 2022, to continue, if necessary, on June 22, 2022. The hearing officer will issue an order scheduling a third hearing. Participants so far in this proceeding have included the Illinois Groundwater Advisory Council and many industry representatives. The rulemaking, which has not gone to first notice, is captioned Proposed Amendments to Groundwater Quality (35 Ill. Adm. Code 620), docket R22-19.

RULEMAKING UPDATE

Board Proposes "Identical-in-Substance" Amendment to Wastewater Pretreatment Rules

On February 17, 2022, the Board proposed—for public comment—an amendment to Illinois' wastewater pretreatment rules. The amendment will keep these rules "identical in substance" to those of the United States Environmental Protection Agency (USEPA). The Board's rulemaking responds to a single USEPA action taken during the first half of 2021. On May 19, 2021, USEPA updated the methods for analyzing contaminants in wastewater, including for wastewater pretreatment. USEPA's analytical methods are incorporated by reference in the Illinois wastewater pretreatment rules, and simply updating that incorporation by reference will complete Board rulemaking on USEPA's action.

The proposed amendment was published in the *Illinois Register* on March 4, 2022 (46 Ill. Reg. 3497). The Board expects to adopt the final rule in May of this year.

The Board's rulemaking is captioned <u>Wastewater Pretreatment Update</u>, <u>USEPA Regulations (January 1, 2021 through June 30, 2021)</u>, docket R22-7. Board Proposes "Identical-in-Substance" Amendments to Ambient Air Quality Standards

On February 17, 2022, the Board proposed rule amendments to Illinois' ambient air quality standards. The amendments will keep these standards "identical in substance" to the National Ambient Air Quality Standards (NAAQS).

The Board's rulemaking primarily responds to two actions taken by the United States Environmental Protection Agency (USEPA) during the first half of 2021. First, on March 4, 2021, USEPA designated a new federal reference method for monitoring sulfur dioxide in ambient air. As USEPA's methods are incorporated by reference in the Illinois ambient air quality rules, the Board proposes updating that incorporation by reference. Second, on March 26, 2021, USEPA issued its Round 4 area attainment status designations for the 2010 primary NAAQS for sulfur dioxide. Among the several areas across the country, USEPA designated Macon County "attainment/unclassifiable." That was the final area designation for areas in Illinois. The effect is that the 1971 primary NAAQS for sulfur dioxide will no long apply in Illinois as of April 30, 2022. The Board therefore proposes removing the 1971 NAAQS from the Illinois rules.

The proposed amendments were published in the *Illinois Register* on March 4, 2022 (46 Ill. Reg. 3485). The Board will hold a public hearing on April 21, 2022, to satisfy federal requirements for the revision to the State Implementation Plan that will result after the Board adopts the amendments. The Board expects to adopt the final rules in May of this year.

The Board's rulemaking is captioned National Ambient Air Quality Standards Update, USEPA Regulations (January 1, 2021 through June 30, 2021), docket R22-8. Board Announces Proposed Rules for 90-Day Comment Period in CCR Sub-Docket

In its rulemaking addressing coal combustion residual (CCR) surface impoundments, the Board opened a sub-docket to explore four separate issues in more detail:

- Historic, unconsolidated coal ash fill in the State
- The use of temporary storage piles of coal ash, including time and volume limits
- Fugitive dust monitoring plans for areas neighboring CCR surface impoundments
- The use of environmental justice screening tools

The Board solicited public comment on the four issues and received fourteen comments. One comment provided substantial information and proposed rule text on each of the four sub-docket issues. It was filed jointly filed by the Environmental Law & Policy Center, Little Village Environmental Justice Organization, Prairie Rivers Network, and Sierra Club (collectively Environmental Groups)

On March 3, 2022, the Board issued an order that presented the Environmental Groups' proposed rule text for a 90-day public comment period, closing June 3, 2022. The Board made no comment on the substance of the Environmental Groups' proposed rules. At the close of the public comment period, the Board will reexamine the issues and determine whether to proceed to hearing.

As of publication of this *Environmental Register*, a pending motion filed by the Environmental Groups asks that the Board allow until August 2, 2022, for all participants to file comments responsive to comments filed by the June 3, 2022 deadline.

Board Proposes Drycleaning Facility Rules for First Notice and Opens Sub-Docket on Drycleaner Continuing Education

On March 3, 2022, the Board issued an order proposing first-notice rules on licensing drycleaning facilities, overseeing their environmental insurance coverage, and administering State fund reimbursement for the costs of cleaning up drycleaning solvent releases. This rulemaking was initiated by the Illinois Environmental Protection Agency (IEPA) to address amendments to the Drycleaner Environmental Response Trust (DERT) Fund Act. These statutory amendments transferred oversight and implementation of the DERT Fund from the DERT Fund Council to IEPA. After receiving IEPA's rulemaking proposal, the Board held public hearings and received public comment.

For first notice, the Board proposed adopting new Board rules at 35 Ill. Adm. Code Part 1501 and repealing DERT Fund Council rules at both 35 Ill. Adm. Code Part 1500 and 2 Ill. Adm. Code Part 3100. These rule changes are designed to protect the environment and smoothly transition drycleaners to a new regulatory program. On March 18, 2022, the proposal was published in the *Illinois Register* (46 Ill. Reg. 4575, 4621), meaning that anyone may file a public comment with the Board concerning the first-notice proposal until at least May 2, 2022.

Restricted Status/Critical Review

The Environmental Protection Act prohibits the Agency from issuing a construction permit that will cause or extend a violation. A construction permit to expand the distribution system cannot be granted when a water supply has a maximum contaminant level or treatment technique violation, an inadequate source of raw water supply, inadequate treatment plant capacity, finished water storage or distribution system pressure. A Restricted Status List is published quarterly in the Illinois Pollution Control Board Environmental Register to notify those persons considering expansion of a water supply distribution system of that status before large sums of money have been spent on items such as land acquisition, financing and engineering fees. A companion Critical Review List is published concurrently with the Restricted Status List and has the water supplies that are approaching a point where the supply could be placed on Restricted Status. A permit application from a supply on Critical Review will be examined carefully to ensure that the proposed construction will not cause a violation. The current list reflects the status as of April 15, 2022. An asterisk, *, beside the water supply indicates public water supplies that have been added to the Restricted Status/Critical Review list since the previous publication.

Restricted Status List

The Restricted Status List was developed to give additional notification to officials of public water supplies which are in violation of 35 Ill. Adm. Code, Subtitle F: Public Water Supplies, Chapter I or the Illinois Environmental Protection Act.

The Restricted Status List will include all Public Water Supplies for which the Agency has information indicating a violation of any of the following requirements: Finished water quality requirements of 35 Ill. Adm. Code, Part 611; maintenance of adequate pressure on all parts of the distribution system under all conditions of demand; meeting raw water quantity requirements; or maintenance of treatment facilities capable of providing water "assuredly adequate in quantity" as required by Section 18 of the Illinois Environmental Protection Act.

A public water supply on the Restricted Status List will not be issued permits for water main extensions, except for certain limited situations, or unless the supply has been granted a variance from the Illinois Pollution Control Board for the violation, or from permit issuance requirements of Section 39 of the Act. This list is continually being revised as new information becomes available, and therefore, specific inquiries as to the status of any public water supply should be directed to the Division of Public Water Supplies for final determination.

Critical Review List

The Critical Review List was developed to give additional notification to officials of public water supplies which may be close to being in violation of 35 Ill. Adm. Code, Subtitle F: Public Water Supplies, Chapter I or the Illinois Environmental Protection Act.

A supply will be placed on the Critical Review List when Agency records indicate that it is approaching any of the violations that would place it on the Restricted Status List.

This list is continually being revised as new information becomes available, and therefore, specific inquiries as to the status of any public water supply should be directed to the Division of Public Water Supplies for final determination.
