
HEARING OFFICER ORDER

On June 26, 2014, all parties participated in a telephonic status conference with the hearing officer. Discussions centered on the additional questions from the Board served and filed on June 25, 2014. The petitioner stated that it needed more time to review the additional questions and respond accordingly. To that end, petitioner requested that the hearing in this matter scheduled for July 1, 2014, be cancelled and rescheduled at a later date.

By agreement, the hearing scheduled for July 1, 2014, was cancelled and a new hearing date, possibly mid-August, will be discussed at the next telephonic status conference noted below.

The parties or their legal representatives are directed to participate in a telephonic prehearing conference with the hearing officer on July 15, 2014, at 10:00 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. IT IS SO ORDERED.




