
HEARING OFFICER ORDER

On January 27, 2015, respondent Metropolitan Water Reclamation District of Greater Chicago (MWRD) requested via e-mail an extension of time to file its response to petitioners motion for reconsideration to and including February 18, 2015, the same date the Illinois Environmental Protection Agency's response is due. Petitioners represented that they have no objection. MWRD's motion is granted. MWRD must file its response on or before February 18, 2015.

It is noted that the next status conference is scheduled for February 10, 2015. If the parties wish to reschedule due to the Agency's extension of time, inform the hearing officer of alternative dates.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on February 10, 2015, at 11:00 a.m. The telephonic conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


