We would like for the Board to consider a review of the above case due to the following.



Due to this we were not given the opportunity to remedy the situation. Had we been notified in 2011 we would not be at this point today. It should also be noted that I, Gary Maddock do not own nor operate said property. I merely assist my mother in collecting rents or making repairs to her rental properties.

We wish to also advise you that corrective measures have been taken and this site cleaned and cleared of debris. We have attached photographs for your review, as well as copies of disposal invoices. We would welcome a follow up visit by the IEPA.

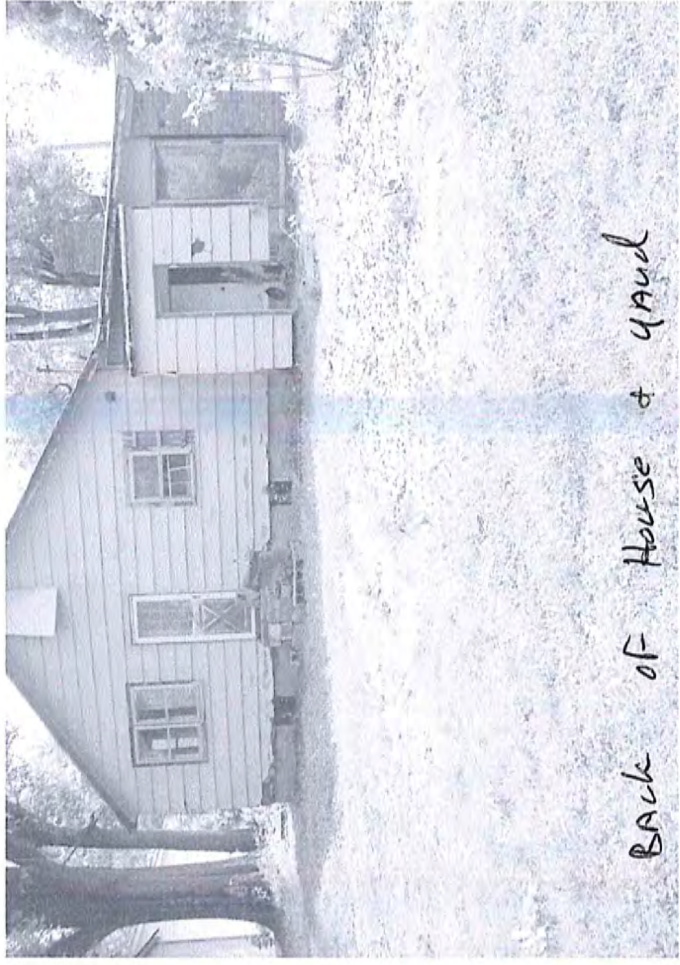

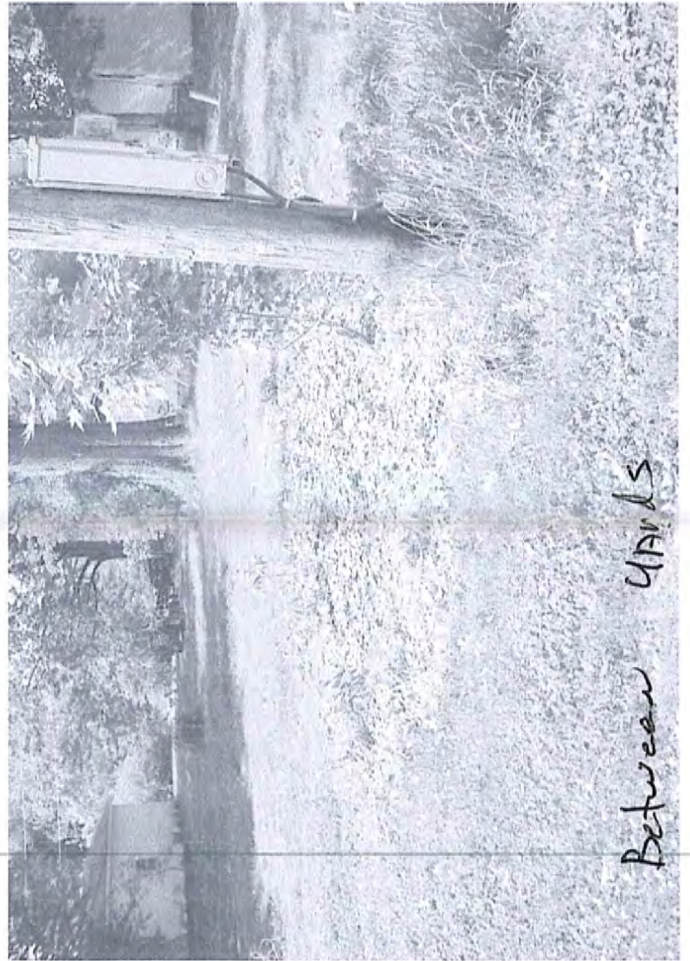

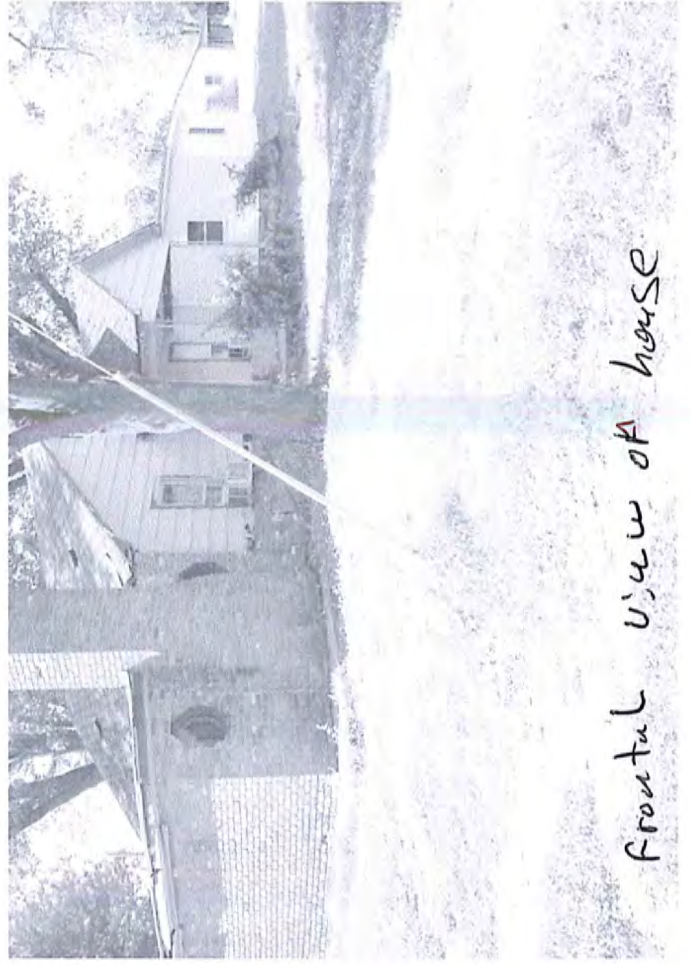

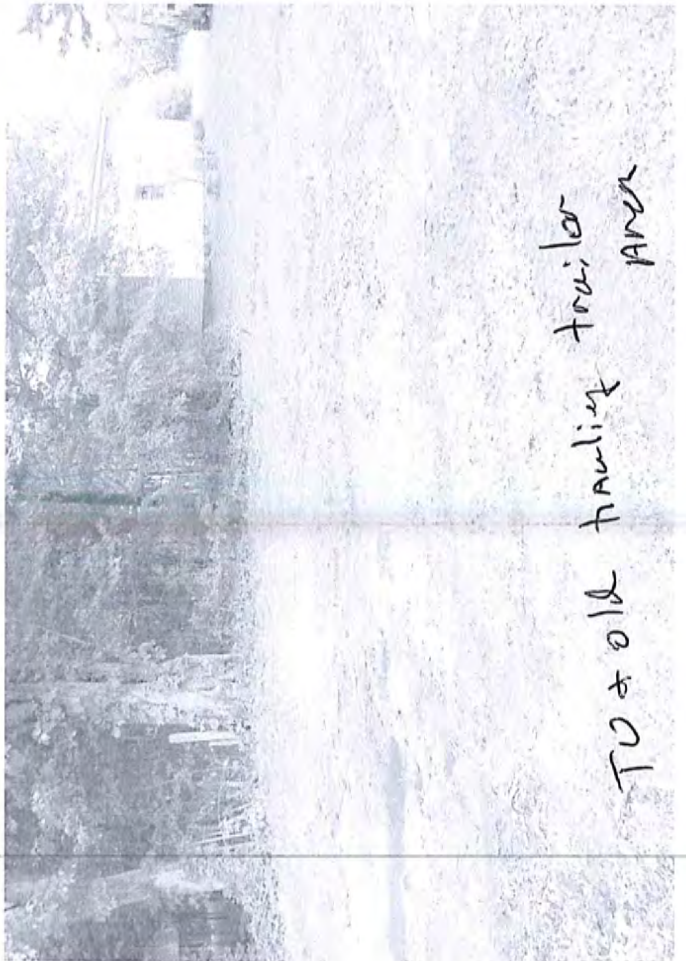

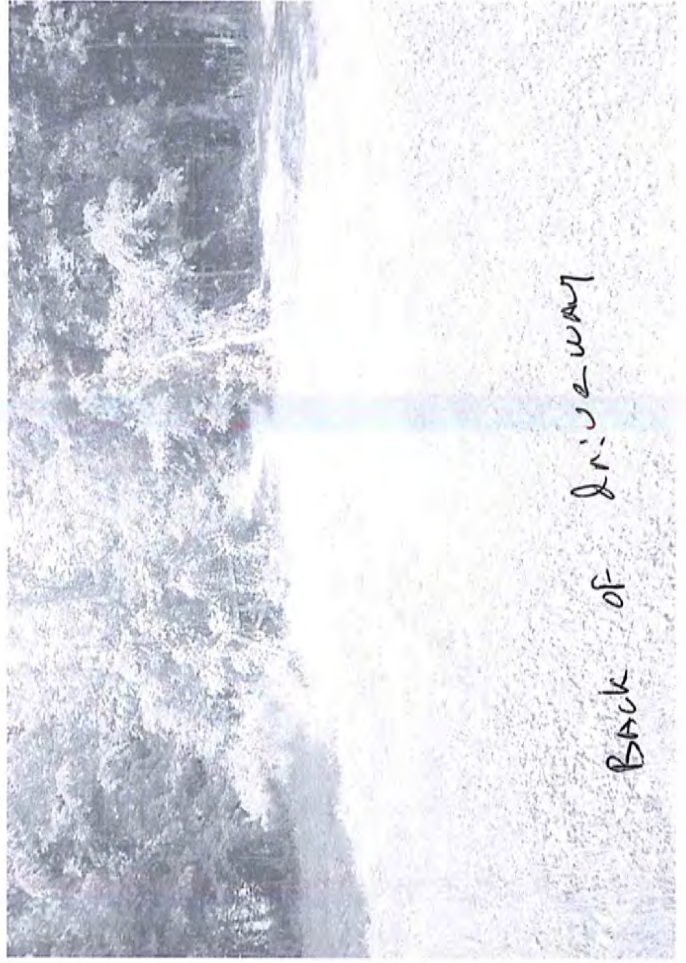
