PETITIONER'S RESPONSE TO RECOMMENDATION OF ILLINOIS ENVIRONMENTAL PROTECTION AGENCY

Pursuant to 35 Ill. Adm. Code 104.220, Petitioner Village of Orland Park ("Village") submits the following response to the Recommendation of Illinois Environmental Protection Agency ("Recommendation") to the Illinois Pollution Control Board ("Board") regarding the Village's Petition for Chloride Time-Limited Water Quality Standard for the Defined Chicago Area Waterway System/Des Plaines River Watershed.

In accordance with the requirements of 35 Ill. Adm. Code 104.216, the Illinois Environmental Protection Agency (Illinois EPA) filed its Recommendation on April 5, 2019. On page 16 of the Recommendation, under the "New Proposed Paragraph 16: Berms", the Village is unclear as to what is meant by "working area". Is the intent to capture runoff from the area used for unloading delivery trucks and loading spreader trucks? Also, under that same section, the Village seeks clarification as to what are the disposal options for the collected effluent.

On page 17 of the Recommendation, under the "Proposed BMP Paragraph 4", the Village seeks clarification if the tarping of trucks refers to salt delivery trucks or salt spreading trucks. Tarping of salt spreading trucks could be problematic due to the small size of the dump body and typical overhead loading methodology. Tarp damage is likely to occur on a regular basis. In addition, the Village would note that logistically, it will be extraordinarily difficult to capture wash water

from cleaning trucks. A separate area would need to be constructed large enough to accommodate several trucks at the same time with all of the effluent being captured and stored in a holding tank. It is not clear how the Village would dispose of the effluent.

Finally, the Village would note that pre-wetting on one-ton plow/spreaders is very difficult without expanding the size of the truck to accommodate the required equipment. Larger trucks create a turning radius that makes it impractical for plowing courts, the typical use.

The Village appreciates the opportunity to respond to Illinois EPA's Recommendation.
