**VILLAGE OF GLENWOOD’S RESPONSE TO RECOMMENDATIONS OF THE ILLINOIS ENVIRONMENTAL PROTECTION AGENCY.**

Pursuant to 35 Ill.Admin.Code 104.220, Petitioner, Village of Glenwood, (øVillageö) submits the following response to the Recommendations of Illinois Environmental Protection Agency (øRecommendationsö) filed on April 5, 2019 with the Illinois Pollution Control Board (øBoardö) regarding the Village’s Petition for Chloride Time-Limited Water Quality Standard for the Defined Chicago Area Waterway System/ Des Plaines River Watershed.

1. BMP 4 includes tarping of salt trucks. To the extent this is intended to apply to salt spreading trucks it will be difficult and dangerous to implement. The trucks are typically loaded by a wheeled loader and then drive off to plow and spread the salt. Tarping would either require the construction of some type of tarping platform, or require the driver to climb on the truck securing the tarp. Either of these would be dangerous during snow and icing conditions. Requiring these dangerous operations is not justified by the benefit of tarping these trucks. The purpose of tarping trucks would be to minimize salt from escaping. But, this would have a negligible benefit when the very purpose of the truck’s operations is the spreading of salt. Whether a tarp is present or not, all the salt present will be used.

2. BMP 4 also includes the disposal of wash water from trucks and spreaders. The Village would need to construct some type of underground basin or containment system, and build a new pad so that all the wash water is collected. Further, what is to be done with the collected salt water?

What is the purpose of constructing an underground containment system, if the contents that are contained end up being released?

3. BMP 16, the BMP suggests using a sump or holding tank or lined basin for collection of water collected from the working area. As in BMP 4, clarification is needed as to how this collected water can be disposed of. What would be done with this collected water?
