Code § 101.308(c)(2), and hereby agrees to a limited waiver of the statutory 120-day decision deadline in this proceeding until June 30, 2020. - 1. On April 8, 2013, Petitioner filed a Petition for Review ("Petition") of the Clean Air Act Permitting Program ("CAAPP") permit (No. 96030056) ("Permit") issued to Petitioner, on March 4, 2013, by the Illinois Environmental Protection Agency ("Illinois EPA") for Petitioner's integrated steel mill plant located in Granite City, Illinois.
- 2. On April 18, 2013, the Board accepted Petitioner's Petition for hearing. Board Order, *United States Steel Corporation v. Illinois EPA*, PCB No. 13-53 (Ill.Pol.Control.Bd. Apr. 18, 2013).
 - 3. The current decision deadline for this matter is December 19, 2019.

4. Petitioner hereby voluntarily agrees to a limited waiver of the statutory 120-day decision deadline until June 30, 2020.
