
HEARING OFFICER ORDER

On January 9, 2020, a telephonic status conference was held. Respondent Marino Development LLC., (Marino), or its legal representative did not appear. Complainant stated that it is discussing internally on how to proceed as to Marino.

Complainant stated that it and respondent A-W-Bennett Enterprises (A-W-Bennett) have a stipulation and proposal for settlement (stipulation) that is being circulated for signatures.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 10, 2020 at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation as to A-W Bennett is filed prior to the next status conference, A-W Bennett does not need to appear.

IT IS SO ORDERED.




