Mr. Rehn and Ms. Flores,

Thank you for your inquiry. I will be asking our Clerk to put this e-mail exchange on the record in the R20-19 docket.

If requested, the Board will do its best to attempt to hire a certified translator for the public comment portion only of the first hearing in this matter. Those times are: August 12, 2020, from 5 p.m. to 7 p.m. and August 13, 2020, from noon to 1 p.m. The translator will translate oral public comments made in Spanish into English for transcription by the court reporter. If a member of the public wishes to make a written public comment, they are welcome to make it in Spanish and we will have it translated for entry into the record. Again, the Board will give equal weight to written and oral comments.

At this time, we are unable to have an interpreter translate the entirety of the hearings into Spanish (or any other language). As a reminder, the full transcripts of both hearings will be made available to the public on the Board's website in this docket and any member of the public is welcome to watch the hearings on WebEx.
