**HEARING OFFICER ORDER**

The Board held the first hearing in this proceeding as scheduled on Thursday, December 10, 2020. During the hearing, a single witness testified: Mr. Rory Davis, manager of the Regulatory Development Unit in the Air Quality Planning Section of IEPA's Bureau of Air.

**Hearing Date Confirmed**

The hearing officer confirmed that the second hearing would take place as originally scheduled on Thursday, January 7, 2021, beginning at 9:00 AM by videoconference between the Board's Chicago and Springfield offices and by WebEx. Below this order provides WebEx connection information for the second hearing.

For a videoconference hearing, any document to be offered as a hearing exhibit must be received by the Clerk's Office at least 24 hours before the scheduled start of the hearing. 35 Ill. Adm. Code 102.424(h). If not filed at least 24 hours before the scheduled start of the videoconference hearing, the document will not be admitted as an exhibit at the hearing but may be filed as a public comment after the hearing. *Id.*

Please note that the Board has a regular meeting scheduled at 11:00 AM on January 7, 2021. If necessary, the Board intends to recess the hearing to conduct its meeting and then resume the hearing.

**Deadline to Pre-File Testimony Confirmed**

The hearing officer also confirmed the original deadline of Wednesday, December 30, 2020, to pre-file testimony for second hearing.

**Deadline to Respond to IEPA Motion to Amend**

During the hearing, the hearing officer noted that IEPA on December 9, 2020, filed a motion to amend its rulemaking proposal. The hearing officer also set Wednesday, December 30, 2020, as the deadline for any participant to file a response to IEPA's motion.

**Deadline for IEPA Responses**

Finally, Mr. Davis indicated that IEPA would respond in writing to specified questions raised during the hearing. The hearing officer also set Wednesday, December 30, 2020, as the deadline for IEPA to file its responses to those questions.
