

HEARING OFFICER ORDER

On March 24, 2021, a telephonic status conference was held. Respondent did not appear. Petitioner reported that the testing data is complete but unclear whether any exceedances and therefore in discussions with the respondent. The petitioner stated that it intends to file an additional joint motion to stay for a period of 90 days. Petitioner has forwarded the motion to the respondent for review. It is noted that the Board granted a stay until March 10, 2021, and that the petitioner has timely filed all required status reports. *see* Ingredion Incorporated v. IEPA, PCB 19-32, slip op. at 1, (Sept. 19, 2019).

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on April 22, 2021, at 10:00 a.m. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. The petitioner has provided a call-in number.

IT IS SO ORDERED.




