
HEARING OFFICER ORDER

On August 18, 2021, the Illinois Environmental Protection Agency (IEPA), filed a motion for extension of time (Mot.), for an additional 90-days to file its Recommendation. The IEPA states that it has contacted counsel for Midwest Generation who indicated they have no objection. Mot. at 4.

The IEPA's motion is granted and its Recommendation is now due on or before November 22, 2021.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 2, 2021, at 9:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. The petitioner is to provide a call-in number. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




