
HEARING OFFICER ORDER

On January 21, 2022, the Illinois Environmental Protection Agency (IEPA), filed a motion for extension of time to file its Recommendation (Mot.), to and including February 4, 2022. Counsel for the IEPA reports that she was in a “vehicular accident” on January 12, 2022, and needs more time to complete its Recommendation. Mot. at 4. Counsel states that the petitioner has no objection to the extension. *Id.*

The IEPA’s motion to file its Recommendation for Pond 2 is granted and it is now due to be filed on or before February 4, 2022.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on February 15, 2022, at 10:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. The petitioner is to provide a call-in number. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




