HEARING OFFICER ORDER


On January 21, 2022, the Illinois Environmental Protection Agency (IEPA), filed a motion for extension of time to file its Recommendation, to and including May 21, 2022. (Mot.) The IEPA reports that it and the petitioner have engaged in discussions regarding the facts alleged and the relief requested in the Amended Petition filed September 17, 2021. Mot. at 3. The IEPA states that on January 21, 2022, the United States Environmental Protection Agency issued additional determinations and interpretations that may be implicated by the Petition. *Id.* at 4. The IEPA requests additional time to review said information. *Id.* The IEPA states that petitioner has no objection to the extension requested. *Id.*

The IEPA's motion for extension is granted to the extent that its' Recommendation is now due on May 23, 2022.

During a conference call on January 26, 2022, it was agreed that a telephonic status conference will be held on the date and time noted below.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on May 26, 2022, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. The petitioner is to provide a call-in number. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


