**MOTION FOR EXTENSION OF TIME**

The Illinois Environmental Protection Agency (“Illinois EPA” or “Agency”), by and through its attorney, hereby submits its Motion for Extension of Time and requests an extension of time, up to and including August 1, 2022, to file its recommendation concerning the Petition of Midwest Generation LLC for an Adjusted Standard from Section 845.740(a) and Finding of Inapplicability of 35 Ill. Admin. Code 845 (“Part 845”) at its Waukegan Station, stating as follows:

1. On May 11, 2021, Petitioner filed its Petition for Adjusted Standards from Part 845 (“Petition”).
2. The Agency’s recommendation is due on or before May 23, 2022.
3. The Agency has been working diligently to evaluate and complete recommendations concerning Petitioner’s requests as contained in the Petition.
4. Lead Counsel, Christine Zeivel, is currently out on medical leave. Therefore, the Agency needs more time to file the Recommendation and get other attorneys within the Agency up to speed on this Petition.

WHEREFORE, Illinois EPA requests the Illinois Pollution Control Board grant its Motion for Extension of Time and grant the Agency up to and including August 1, 2022, to file its recommendation with the Board.
