HEARING OFFICER ORDER


On May 18, 2022, the Illinois Environmental Protection Agency (IEPA) filed a motion for extension of time to file its Recommendation concerning the above-captioned petition up to and including August 1, 2022. (Mot.). The IEPA states that it “has been working diligently to evaluate and complete the recommendation.” Mot. at 3. The IEPA also states that the lead counsel on this matter is out on medical leave. *Id.* On May 19, 2022, counsel for petitioner stated, *via* email, that she has no objection to the motion.

The IEPA’s motion for extension is granted and its Recommendation is now due to be filed on August 1, 2022.

Should the parties wish to reschedule the status conference noted below due to this extension, contact the hearing officer.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on May 26, 2022, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. The petitioner is to provide a call-in number. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




