HEARING OFFICER ORDER

On June 6, 2022, the Agency filed a motion for extension of time to July 25, 2022, to file the administrative record. On June 10, 2022, Williamson Energy, LLC responded that it had no objection to the motion.

On June 23, 2022, the parties participated in a telephone status conference with the hearing officer. Petitioners stated that they do not object to the Agency's motion. The motion is granted, and the administrative record is due by July 25, 2022.

On July 8, 2022, Williamson Energy, LLC agreed to file a deadline waiver to September 1, 2023, to allow time for a summary judgment schedule. The parties have agreed that cross motions for summary judgment are due by September 9, 2022, responses are due by October 21, 2022, and replies are due by November 8, 2022. The parties will also discuss a stipulation of facts.

The parties may contact the hearing officer to schedule a status call if any problems arise.

The last Board meeting before the decision deadline is currently December 8, 2022.
