**HEARING OFFICER ORDER**

This order is issued to set the date and time for a prehearing conference in this rulemaking. All participants interested may attend a prehearing conference on August 1, 2022, at 10 a.m. Participants may attend by calling 1-888-494-4032 and entering the access code 7139237824#.

The purpose of the prehearing teleconference will be set two consecutive dates for the third hearing in this matter. Participants filed a joint motion on July 22, 2022 requesting an extension of time to prefile testimony as well as requesting a change to the date of the third hearing, already noticed in this matter for November 1, 2, and 16, 2022. As has been explained multiple times to participants, the sale of the Thompson Center in Chicago has limited the Board's access to larger hearing rooms in Chicago that have videoconference capabilities. Currently, a conference room in the Bilandic Building at 160 N. LaSalle St., Chicago, is available the week of December 5, 2022. Participants are to attend the prehearing teleconference prepared to inform the hearing officer of their availability on two consecutive days during the week of December 5, 2022. If participants are able to agree on two consecutive days during the week of December 5, 2022, the hearing officer will cancel the hearing dates of November 1, 2, and 16, 2022, and adjust the pre-filing schedule as follows:

Prefiled testimony will be due September 15, 2022.  
Prefiled questions will be due October 27, 2022.  
Prefiled answers will be due November 23, 2022.


If participants are unable to agree on two consecutive dates during the week of December 5, 2022, the original Will County third hearing dates of November 1, 2, and 16, 2022, will be kept and the pre-filing schedule will be adjusted as follows:

Prefiled testimony will be due September 2, 2022.

Prefiled questions will be due September 30, 2022.  
Prefiled answers will be due October 24, 2022.

No further changes to the third hearing will be granted by the hearing officer. An additional hearing officer order will be issued following the prehearing teleconference on August 1, 2022, summarizing the teleconference and setting the revised prefiling schedule.
