MIDWEST GENERATION, LLC'S UPDATE ON STATUS OF PERMIT APPLICATIONS FILED WITH ILLINOIS EPA

Pursuant to the Illinois Pollution Control Board's December 15, 2022 Order, Respondent, Midwest Generation, LLC, ("MWG"), submits this update on the status of its Part 845 permit applications:

- 1. Joliet 29 Station The operating permit application and construction permit application for the CCR surface impoundment was timely submitted to Illinois EPA. Illinois EPA has not issued a draft or final operating or construction permit.
- 2. Powerton Station The operating permit applications were timely submitted for the CCR surface impoundments to Illinois EPA. MWG submitted construction permit applications for two of the CCR surface impoundments to Illinois EPA in 2022 and will submit the construction permit applications for the two remaining CCR surface impoundments to Illinois EPA in 2023. Illinois EPA has not issued draft or final operating or construction permits.

3. Waukegan Station – The operating permit applications and construction permit applications for the CCR surface impoundments were timely submitted to Illinois EPA. Illinois EPA has not issued draft or final operating or construction permits.

4. Will County - The operating permit applications were timely submitted for the CCR surface impoundments to Illinois EPA. The construction permit applications for the CCR surface impoundments will be submitted to Illinois EPA in 2023. Illinois EPA has not issued a draft or final operating permit.
