**HEARING OFFICER ORDER**


On March 28, 2023, all parties participated in a telephonic status and petitioner subsequently filed a written motion for an extension of time to file its Response to the Illinois Environmental Protection Agency’s (Agency) Recommendation (Mot.).

Petitioner states that “[d]ue to the length and complexity of the Agency’s Recommendation, an extended medical leave by MWG’s counsel, and potential changes currently pending with respect to the Waukegan Station that may impact MWG’s response, MWG requires additional time to complete and file its Response. Mot. at 2. “Accordingly, MWG respectfully request that the Hearing Officer extend the deadline to respond to July 28, 2023.” Id. Petitioner states that the Agency takes no position on MWG’s motion. *Id.*

Petitioner’s motion is granted, however, no further motions for an extension of time will be entertained.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on May 4, 2023, at 10:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. The petitioner is to provide a call-in number. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




