Dear Mayor Burke:

**RE: Unresolved Water Issues, Damage to Property
Spaulding Avenue, Evergreen Park, IL 60805**

Alley flooding has drastically increased over the last 10 years. It was recently brought to my attention that the alley location at 9300 S Spaulding and 9300 S Sawyer has no sewers. I have also been made aware that my property is the lowest spot, with homes seeping water continuously from rain, snow, and draining of pools.

What I thought was alley grading problems is much more severe. I recall having a conversation with the street department saying that my property fell. My engineering report confirmed there is absolutely no evidence of such claim and therefore, the claim has been found to be completely false.

The flooding, in conjunction with the neighbor problems from the garage permit at the premises of 9317 S Spaulding Avenue, has contributed to the flooding and therefore damage to property and land. All FOIA attempts for the garage was unsuccessful, your office provided me with blank pages.

2014, Alley grading, over time, changed the natural flow of water. Heavy downpours occurred and turned the alley into a river, diverted from the north and south, that entered into my yard, causing my shed to flood and take on water. I urgently called the village to help stop the water from entering my yard. The village ignored my call. The next rain, again, I urgently called the village to help stop the water from entering my yard. Yet again, the village ignored my call. My pleads were ignored time and time again. After many more calls from more rain storms, I was informed by the Street Department that the village had no money in the budget to address the alley flooding into my yard. Therefore, I demanded sand bags at the least, to be placed along the perimeter of the fence, to stop the flow of water into my yard and flooding my shed. The sandbags sat there for three (3) years.

2016, October, the street department had performed work on the alley. A sewer was added. I recently found out that the sewer is not connected to any sewer lines. The sewer never had water entering and has always been dry. The water never reaches the sewer, it seeps all underground. The water from the pools and the neighbor's invasive mulberry bushes have invaded my yard and the root system has rotted and suffocated the fragrant heirloom Mock Orange Bush that had always been treasured when in full bloom.

I had a landscape company look at the situation to mitigate damages. Drain tiles, or some version of, were suggested along the perimeter between 9313 and 3917 S Spaulding. The landscaping company refused to give an estimate for the work due to liability. I do not own the land between the lots and sewer would be required. At the time, I did not understand that there was no sewer system to tie into.

2019, November, I was informed by the Cook County Mosquito Abatement District, that during mosquito season they are in constant contact with the Village of Evergreen Park; weekly meetings with water management division about standing water, catch basins, overgrowth areas both public and private.

The village alley vegetation overgrowth, the neighbor vegetation overgrowth, the green pools not maintained by neighbors, and the water pooling near the tracks and in the alley after rain storms, is harboring mosquitos contributing to the increase of mosquito population.

2019, December, a well renowned, building inspection service company completed an inspection on my garage. The report determined damages from water and vegetation caused by the property at 9317 S Spaulding. The building department had repeatedly refused to inspect the garage and perimeter over a period of years of complaints, caused by the neighbor at 9317 S Spaulding.

The village approved a garage permit that resulted in a concrete slab that is still there today. The water runs off towards my property and behind her property that collects and causes standing water in multiple locations. The engineer recommended that the garage wall in this area should be excavated back to expose the foundation and brick. The increase in ground elevation, year over year, from dumping of grass clippings along the perimeter had contributed to the increase. Landscape, year after year, dying back and decaying, continues to increase the ground level and more water to run off causing more damages. The tree roots also contribute to ground level increase. The village refused to take action and protect my garage at Spaulding.

Many times, I requested an inspector from the village to fine the neighbor at 9317 S Spaulding for numerous violations contributing to my water, flooding, and other nuisances, as documented in the ordinances. I called by phone, requested assistance from the on-line Help Center/Request Assistance, written letter of communication. All have been ignored.

I went to the village board meeting informing the village to replace the crosshatch markers on the sidewalk that were removed by the village during construction of new sidewalks. In addition, all metal pins were not detected because the metal pins were also removed.

(765 ILCS 205/) Plat Act

Sec. 11. Any unauthorized person who knowingly damages, destroys or removes a stake, pin, monument or other survey marker shall, be guilty of a Class A misdemeanor. For purposes of this Section, a surveyor who moves a stake, pin, monument or other survey marker for the purpose of correcting a survey is an authorized person.

(Source: P.A. 77-2561.)

2020, January, a new plat of survey had to be ordered after the village refused to replace the "original" missing boundary markers. Let me be clear, it was not my responsibility to replace the missing pins, that cost \$450.00, at my expense. However, it was required in an effort to find options to stop the damages. That is when the surveyor noticed that all the pins had been removed from the entire block, creating more work than normal.

2020, May, after many attempts to request assistance, the village refused to take action. Barbara Spanos, homeowner located at 9317 S Spaulding Avenue, Evergreen Park, was served a cease-and-desist letter detailing the municipality ordinance and state laws. Ms. Spanos failed to correct.

2020, June, Mayor Sexton was sent a copy of that cease-and-desist letter that adversely affected my property and contributed to the flooding and other nuisance issues. Geoffrey Layhe, Supervising Inspector, responded by visiting the owner at 9317 S Spaulding. The village said the neighbor refused to provide access. Since I own 3 inches, I have the authority to provide access. Regardless, the village does not need to ask for approval in this situation.

Village Attorney, Mr. Cainkar, replied and characterized the complaints and cease-and-desist as "neighbor disputes" and civil suit rather than police action.

2020, July, the flooding, years earlier, caused my shed to be under water and needed to be replaced. An expense that the village should have been responsible to pay.

I hired Moltor Corporation. Moltor paid the village his license fee. He was to add a concrete pad for the shed, per the building department requirements. The owner had fallen ill and was in the hospital for months. The price of concrete was extremely high during Covid, so I cancelled the project and asked for refund be made to the contractor in the amount of \$225.00

2020, September, I emailed Cathy Aparo, Village Clerk, requesting the process for license fee refund. Cathy Aparo, Village Clerk, said she was unaware of the process. I was to speak with Ed Clohessey, Building Commissioner. He was belligerent and said the contractor needed to make that request after the calendar year is completed. I informed the contractor of the instructions. At the beginning of following year, the contractor request was denied, having been informed the request was too late and should have been requested before the end of the year. I wrote a letter you, Ms. Burke about this situation. You denied the refund because you said that the village has no current process. Evergreen Park has been incorporated since 1893. Your attempt to claim that there was no refund process for work that gets cancelled, is ridiculous.

2021, September, Judge commented that my complaint was a municipality issue to be resolved by the municipality. Civil complaint was dismissed.

2021, September, a FOIA request listed Evergreen Park Inspectors and their qualifications. Memo from Geoffrey Layhe, Building Department Supervising Inspector, stated that the Village of Evergreen Park nor the State of Illinois require inspectors to be certified in any particular area.

2021, September, I went to the village hall to discuss unresolved issues with water, flooding, nuisances, etc. with you, Mayor Burke. You, however, refused to speak with me. You refused to schedule a meeting with me to discuss unresolved issues pertaining to my property, among other issues. Instead, you contacted the police and had me escorted out of the village. The officer hand delivered my formal complaint to the clerk for processing from my car parked in the village parking lot. I had made sure that the form was date stamped, forcing the officer to go back to get clarity. I also asked for the calendar inspection date. I was refused that information. I was never informed of the inspection date and time. The camera caught Geoffrey Layhe, Supervising Inspector, at the sidewalk to inspect. The camera caught Mr. Layhe walking away from the property and not completing his inspection properly. The village complaint was closed.

2021, October, International Code Council (ICC) informed me that the water and flooding issues is the responsibility to rectify is that of the village.

2021, October, civil engineer informed me that water and flooding issues is a result of the low spot. The responsibility was that of the village.

2023, September, after area flooding in Cook County, FEMA approved Illinois' request for 19 counties to receive Public Assistance following the severe storms and flooding event on June 29 - July 2, 2023. I reached out to Metropolitan Water Reclamation District. I was informed that the village must initiate the call to the city. The responsibility was that of the village.

I contacted the street department reminding them of the lack of sewers, that I just learned, and my specific situation prone to constant flooding and requested them to contact Metropolitan Water Reclamation District. I informed them I have been made aware of lack of sewers causing all the water seeping and flooding into my yard that has caused a permanent dip in my entire yard.

May I remind you, Ms. Burke, of the duties and power of the Mayor:

Illinois Municipal Code

Appoints all officers of the Village, with the consent of the council, unless otherwise specifically provided by statute (65 ILCS 5/3.1-30-5)

May remove any appointed officer on any formal charge prior to the end of that officer's term whenever he believes that the interests of the municipality demand removal

Executive Officer of Village

Performs all of the duties prescribed by law, including municipal ordinances and is required to see that the laws and ordinances are faithfully executed (65 ILCS 5/3.1-35-5)

Is responsible for seeing that all laws and ordinances are enforced, the Mayor is, in effect, the administrative superior of all officers and employees, other than the alderman (65 ILCS 5/3.1-10-40)

July 2023, now comes, federal regulation, 44 CFR 60.3A Flood Plain Management. I believe you have been duly informed of this matter and your responsibility to the federal government and the residents of your municipality.

You are notified that which has not been rectified by water, flooding, and nuisances, will be a village liability and that the village will be held accountable for failure to do the job by you and your administration. You and your administration have engaged in behavior that is willful and intentional to cause harm to me, my property, and my animals as a caregiver.

The flooding is further exacerbated by dense vegetation causing increase in aggressive mosquitos. I have been informing the village repeatedly about the conditions of dense vegetation in the alley and my neighbor, specifically, 9317 S Spaulding Avenue. The areas of concern are dense vegetation, pooling of water along the railroad tracks due to improper diversion of water, excessive pooling of water in the alley at the location of 9317 S Spaulding causing the increase in mosquitos so aggressive and swarms around me and my pets that is a health hazard and public health issue.

In addition to the overgrowth, my health has been impacted by severe allergies that increased this year due to the weeds and noxious weeds now established in the alley and at the neighbor located at 9317 S Spaulding.

The neighbor at 9317 S Spaulding continues to not take action against the invasive shrubs that have invaded my yard, running along the entire perimeter of the lot line. Your administration has taken no action from the cease-and-desist letter provided to the village in 2020. I refer you to the cease-and-desist letter your office were provided.

Further, I am formally documenting the harassment against me by you and your administration. Stop having your administration seek out to harass and force me to move by contributing to the and damage of my property, that I have mentioned in this letter that you and your administration, friends, and family have increased over time. This includes, but not limited to, Rita Alexander-Fulton (sister-in-law to Mark Marzullo), Mark Marzullo, Thomas Egan, Cathy Aparo, Geoffrey Lahey, Annie Williamson, and all the other administration that Cathy Aparo has used to target me, such as Cathy Cericola, Glenn Pniewski Public Information Officer, Frank Clarin Records Supervisor, including the neighbors that Rita Alexander has conspired, and her accomplice, Thomas Egan, to cause physical and mental harm. The comments documented in the police report of death and the threat of seeing me dead by others on this block of 93rd and Spaulding Avenue, is extremely disturbing. You and your administration will be held accountable for any harm caused by those mentioned and due to negligence and liability as set forth in this letter, to me, my property, and my pets.

Most recently, I had contacted your office, left you a message about the theft by your administration to illegally remove my straw bales, at a cost of \$90.00, and attempted to give it to Mary Kay Nielsen, Farm Manger, who refused the items. You refused to respond to my call. You also refused to investigate and take action. The Evergreen Park Police, specifically, Officers Warmczek and Kurschner, refused to investigate when I informed them that Ms. Nielsen confirmed she was offered the straw bales. It is your responsibility to terminate individuals that are breaking the law and I want to press charges against those involved with the theft and conspiracy to all those involved. Stop asking and taking funds from Illinois University, and other institutions, when you are denying the rights of individuals and it does not benefit all the residents of Evergreen Park.

I have been contacting multiple agencies about what has transpired, over time, and I can assure you that the Village of Evergreen Park has a negative reputation. Recently speaking with the Cook County Sheriff at the Bridgeview Courthouse appealing the citation, who also confirmed they have been informed about issues.

Contact me as soon as possible for a quick resolution.

On 01/18/2023 at 0633 hours, I (Ofc. Troglia *134) responded to 9313 S Spaulding Avenue for a public Complaint.

Upon arrival I met with the reporting party, Anna Andrushko, who stated the following, not verbatim: For the last 10 years Anna has been having ongoing issues with her neighbor, Thomas Egan, who lives at 9311 S Spaulding Avenue. Anna advised that Thomas has been harassing her and trying to intimidate her. Anna advised that on more than one occasion, Anna`s feeder box for the neighborhood feral cats has been tampered with. She also stated that the cover to one of her bird baths has also been tampered with. Anna stated that Thomas and Rita Fulton, have been conspiring against her and Anna believes that Thomas is attempting to convince her to move away.

Anna showed me a picture on her cell phone of the feeder box in question. The lid to the box appears to have been removed and intentionally placed up against the back fence to her backyard. The feeder box is located in the alley behind Anna`s house, between her two garbage cans. Anna also showed me the bird bath in question. The bird bath is located in her back yard close to the fence that runs along the alley. The cover to the bird bath was removed and intentionally placed in a location a few feet away from the bird bath.

Anna advised that she would like a report filed to document the tampering with her property. Anna has cameras on the rear of her residence, however, they did not catch anyone moving her property. I advised Anna that i would document the event and she should call EPPD if she continues having issues. I provided Anna with a report slip for this event.

In summary: On 05/27/2021 at approximately 2042 hours, I (Ofc. Sarno #150) was dispatched to take a call back Harassment report for Anna Andrushko, who resides at 9313 S Spaulding Avenue. Andrushko has an extensive call history in regards to complaints about her neighbors, CSX Railroad, and issues with the Village of Evergreen Park.

Using my department issued cell phone (Unit #2910), I contacted Andrushko. Andrushko stated she believes all of her Irish neighbors, trustees and employees for the Village of Evergreen Park are all conspiring against her in order to force her to move out of town. Andrushko stated that she has been dissatisfied with the services from the village and they neglect to take her complaints seriously. Andrushko went on to say that she frequently comments on the Evergreen Patch online page under the surname "JO". Andrushko advised that people using surnames would comment nasty stuff toward her. Andrushko did not specify exactly what nasty things were said. Andrushko would contact the Evergreen Patch to remove the comments if they have not done it already. Today, an unidentified subject under the possible surname of "Sue" commented "Hey Anna, stop with the BS already". Andrushko advised that she is now fearful that more people will conspire against her since her real name is being leaked on the Evergreen Patch. Anna alleges that it is one of the village trustees doing it since they all know who she is.

Andrushko wished to have this documented as a matter of record so that she could provide it to her attorney. I provided Andrushko with a report number. Andrushko thanked me for my time and we ended our conversation. Please note that my BWC camera was recording during the duration of our conversation.

In summary: on 05/24/2021 at approximately 1319 hours, I was assigned to a Public Complaint at 9313 S Spaulding Ave. At the residence, I met with Anna Andrushko who wished to file a delayed complaint about congested traffic from the rail road gates being down. Andrushko stated traffic was congested at many intersections and vehicles were driving down her block at a high rate of speed. Anna was beeped at by an unknown subject in a black vehicle (unknown registration) while she was trying to exit her driveway. Anna wants a camera on her block to alleviate all of the issues that arise (all recirculating issues previously documented). Anna insisted a report be made for her attorney.
