## ILLINOIS POLLUTION CONTROL BOARD

MINUTES OF REGULAR BOARD MEETING
May 23, 1972 - Suite 300, 309 West Washington Street, Chicago, Illinois

All Board Members except Mr. Dumelle were present.

The Board adopted the following opinions and orders by a vote The City of Jacksonville, PCB 71-355, was ordered to eliminate the overflow of lime sludge from its water plant and to complete its plans and specifications for the installation of its lime sludge dewatering equipment. A Motion to Withdraw was granted in Borden Chemical Company, PCB 72-38, and the proceeding was dismissed. Chainbelt, Inc., PCB 72-86, was ordered to cease and desist the discharge of cyanide and heavy metals and a \$2,000 penalty was imposed. A \$200 penalty was imposed in Texaco, Inc., PCB 72-98, for a leak in a brine well which caused temporary strong odor and bad taste in Olney's drinking water. The Petition for Extension of Time in Merlan, Inc., PCB 72-101, was denied. The Metropolitan Sanitary District, PCB 72-110, was granted a variance with respect to its East Chicago Heights sewage treatment plant from Rule 404(b) of the PCB Regs., Ch. 3, until November 23, 1972, and from Rule 404(f) of the PCB Regs., Ch. 3, until May 23, 1973, subject to various conditions. An explanatory opinion regarding the May 17 order of the Board in Crane Packing Company, PCB 72-131 and 132, was adopted. A corrective order in Illinois Power Company, PCB 72-190, was also adopted.

The Mining Regulations, R 71-25, were adopted by a vote of 4-0, after several changes were noted. The Board's opinion explaining the Regulations was also adopted by a vote of 4-0.

Decision on the Motion to Modify the Board's August 5 Order in State Line Foundries, PCB 71-86, was held over until May 30. Mr. Aldrich agreed to prepare the opinion and order in City of Arcola, PCB 72-18, for decision at the next Board meeting. And Mr. Lawton will prepare the opinion and order in the Village of Lake Zurich, PCB 72-26, also for decision May 30.

It was noted that the Metropolitan Sanitary District had met with the Agency and the Institute in connection with the District's Amendments to the Water Quality Standards, R 72-4, and they were planning to meet again for further discussion.

Mr. Sullivan appeared before the Board for discussion of the draft of the <u>Animal Waste Standards</u>, R 72-9. Authorization for publication of the Standards was postponed. Authorization for publication of R 72-8, Repeal of SWB-17, was also put over.

Mr. Harvey M. Sheldon, Assistant Attorney General, then discussed the Board's position in the Cemeteries case (PCB 72-117 et al), and the course of action that should be taken before the Appellate Court of Illinois.

Minutes for May 10 and May 17 were adopted by a vote of 4-0.

Hearings were authorized in the following new cases: Village of Mt. Auburn, PCB 72-213; and City of Geneva, PCB 72-214. Hearings are mandatory in the following new cases: County of DuPage, PCB 72-207; Monsanto Chemical Company, PCB 72-209; Proctor & Gamble, PCB 72-210; Weldon Farmers Grain Co-op, PCB 72-215; Towa-Illinois Gas & Electric Company, PCB 72-216; Park Manufacturing Company, PCB 72-217; J.R. Short Milling Company, PCB 72-218; and City of Mascoutah, PCB 72-219. Action in Sanitary District of Elgin, PCB 72-211, and Village of Peotone, PCB 72-212, was postponed pending EPA recommendation. Mr. Kissel agreed to write an order requesting additional information from the parties in Estella Lewis v. EPA, PCB 72-208.

Finally, the Board agreed to change the Board meeting scheduled for June 8, 1972 in Moline to June 6 at the Board offices, 309 West Washington Street, Chicago.
