MINUTES OF REGULAR BOARD MEETING August 29, 1972 309 W. Washington, Ill.

All Board Members were present.

Opinions and orders were adopted by the Board in the following cases: ##71-316, Milford Chamber of Commerce v. Milford Canning and Armour Co. by a vote of 5-0; 71-341, Wells Lumber, by a vote of 5-0; 71-362, N.J. Zinc, by a vote of 5-0; 72-65, Archdale (interim opinion of the Board), by a vote of 5-0; 72-92, Village of Robbins, by a vote of 5-0; 72-124, Frietsch by a vote of 5-0; 72-165, Great States Theatres, by a vote of 5-0; 72-178, Mark E. Cook, by a vote of 4-1, Mr. Dumelle dissenting; 72-223, Lake County School (opinion only) by a vote of 4-1, Mr. Dumelle dissenting; 72-228, Danville Metal Stamping, by a vote of 5-0; 72-261, Grant Park H.S., (opinion only), by a vote of 5-0.

Mr. Dumelle briefly discussed his opinion and order in #R72-4, Metropolitan Sanitary District's proposed amendments to the WQS. The Board adopted the opinion and order by a vote of 5-0.

Mr. Riddle and Mr. Burkhardt, representing the Consulting Engineers Council of Illinois were recognized by Chairman Currie. They presented an oral outline of recommendations and proposed amendments to the WQS. The Board asked that their proposals be submitted in writing to the Board for further consideration.

The meeting was recessed for lunch until 1:30 P.M.

Discussions were held and set for decisions on Sept. 6, 1972 in the following cases: ##71-333, Howe, Mr. Lawton to prepare an opinion, 71-365, Urbana, Mr. Currie to prepare an opinion; 72-2, Salem, opinion to be prepared by Mr. Henss; 72-41 & 72-144, Richardson, Mr. Currie agreed to draft an opinion; 72-131, Crane Packing, Mr. Parker to prepare an opinion; 72-44, Ohlman, Mr. Henss agreed to prepare an opinion; 72-263, Alladin Flower, Mr. Lawton will draft an opinion; 72-293, E.N. Maisel, Mr. Dumelle agreed to prepare an opinion.

Discussion of #72-54, Union Carbide, was put over until the parties submit additional information.

Action on motions for stay in #R71-23, Air Regulations was postponed pending receipt of the Environmental Protection Agency's response.

Discussions of #R72-7, Air Regs was put over to Sept. 6, 1972 and Mr. Parker agreed to draft a proposal on revisions to the Board's Procedural Rules.

A joint motion to dismiss by the parties in #72-214, Geneva, was granted by a vote of 5-0.

In #72-246, Lewis & Clark College, action on motion by Petitioner for additional time to amend was postponed pending an EPA response.

The EPA Recommendation in #72-297, Illinois Power was discussed. The Board voted 5-0 to ask the Petitioner to respond to the recommendation, Mr. Currie agreed to prepare an order.

In new cases the following action was taken: ##72-343, EPA v. Meadowlark Farms Inc., hearing mandatory; 72-344, EPA v. W.G. Best Homes, hearing mandatory; 72-345, City of Morrison, petition dismissed by a vote of 5-0; 72-346, EPA v. Republic Steel, hearing mandatory; 72-347, Danville Sanitary Dist., petition dismissed by a vote of 5-0; 72-348, EPA v. Hutton et al. hearing mandatory; 72-349, Finch, hearing authorized 5-0;72-350, Commonwealth Ed, hold for EPA Rec., 72-351, Velsicol Chemical Co., variance petition ordered consolidated with #72-326, EPA v. Velsicol; 72-352, City of Carbondale, petition dismissed by a vote of 5-0; 72-353, City of Jacksonville, petition dismissed by a vote of 5-0.

Mr. Currie announced that the next meeting would be held Sept. 6, 1972 instead of the 5th due to the holiday.
