**MINUTES OF REGULAR BOARD MEETING
JANUARY 6, 1994 CHICAGO, ILLINOIS**

All Board Members were present.

In R93-14, RACT for Major Sources Emitting VOM's in the Chicago Nonattainment Area: 25 Tons, an Adopted Rule, Final Order, Opinion and Order was adopted by a vote of 7-0. (JTM)

In R93-22, RCRA Subtitle D Amendments, a Proposed Rule, Dismissal Order was adopted by a vote of 7-0. (GTG)

In R93-30, Contingency Measures for PM10 Emissions: Amendments to 35 Ill. Adm. Code Parts 106 and 212, a Proposed Rule, First Notice, Opinion and Order was adopted by a vote of 7-0. (JTM)

Default Orders were adopted in these Administrative Citations by a vote of 7-0: ##93-57, EPA v. Wesley Simpson; 93-59, Williamson County Solid Waste Office v. Marvin Couey.

Respondent's motion to withdraw its petition for review was granted in #AC 93-21, City of Herrin, by a vote of 7-0. (CAM)

An Order, vacating a November 4, 1993 Default Order, and unless already paid, ordering the Respondent to pay, within 30 days of the entry of the Order, by certified check or money order, a penalty in the amount of \$1,000.00, was adopted in #AC 93-41, Stanley Ray Stewart, by a vote of 7-0. (CAM)

An Order, directing the Petitioner and the Agency to submit status reports on or before January 31, 1994, that provide certain information with a measure of specificity that will aid the Board in assessing whether the parties are making reasonable progress towards the resolution of the outstanding issues, was adopted in #AS 91-10, Cabot Corporation, by a vote of 7-0. (RCF)

An Order, accepting the status report in response to the Board's April 23, 1992 Order staying the permit appeal, and reminding the Petitioner that it has a continuing obligation to submit status reports every 90 days, was adopted in #89-177, CWM Chemical Services, by a vote of 7-0. (JTM)

An Order, granting the Agency's motion for an extension of time until January 18, 1994, to file its response to Petitioner's motion for an Order assessing sanctions and remandment for issuance of an air operation permit without special conditions, was adopted in #89-194, The Grigoleit Company, by a vote of 7-0. (CAM)

An Order, accepting the Petitioner's waiver of the decision deadline until August 2, 1994, the additional appearance of Cynthia A. Faur on behalf of the Petitioner, granting a stay in the

proceedings until April 21, 1994, which allows the Board sufficient time, if necessary to process the case prior to the new decision deadline, and directing the parties to file an updated status report on or before April 8, 1994, was adopted in #90-164, -91-161, Riverside Laboratories, by a vote of 7-0. (CAM)

An Order, accepting the Petitioner's waiver of the decision deadline until August 2, 1994, the additional appearance of Cynthia A. Faur on behalf of the Petitioner, granting a stay in the proceedings until April 21, 1994, which allows the Board sufficient time, if necessary to process the case prior to the new decision deadline, and directing the parties to file an updated status report on or before April 8, 1994, was adopted in #90-165, Riverside Laboratories, by a vote of 7-0. (CAM)

An Order, granting the joint motion to stay review of the record in the matter until after March 31, 1994, was adopted in #91-38, American Waste Processing, by a vote of 7-0. (ED)

An Order, accepting the joint status report, and advising the parties that the Board must receive a further waiver of the statutory decision deadline prior to the Board's January 20, 1994 Board Meeting, or the Board will be required to direct the assigned Hearing Officer to set a hearing schedule, but if such a waiver is timely filed, the Board will re-establish a status report schedule at its January 20, 1994 Board Meeting, was adopted in #91-87, Olin Corporation, by a vote of 7-0. (CAM)

An Order, advising the parties that unless an additional waiver of the decision deadline is received before the Board's next scheduled meeting, the Board will decide the case based on the limited record, and directing the parties to file status reports before January 14, 1994, indicating any remaining issues in the matter and an anticipated schedule for the completion of the matter along with an appropriate waiver of the decision deadline to accommodate that schedule, was adopted in #91-202, Sherex Chemical Company, by a vote of 7-0. (ED)

An Order, accepting the status report, advising the parties that the Board must receive a further waiver of the statutory decision deadline prior to the Board's January 20, 1994 Board Meeting, or the Board will be required to direct the assigned Hearing Officer to set a hearing schedule, but if such a waiver is timely filed, the Board will re-establish a status report schedule at the January 20, 1994 Board Meeting, was adopted in #91-207, Olin Corporation, by a vote of 7-0. (CAM)

An Order, accepting the Petitioner's and Agency's status reports, granting the Petitioner's request to stay the proceedings pending the outcome of PCB 89-184, and requesting the Petitioner to file the appropriate motion dispensing with the matter upon the completion of PCB 89-184, was adopted in #92-23, The Grigoleit Company, by a vote of 7-0. (CAM)

An Order, directing the parties to file a status report with the Board on or before March 7, 1994, was adopted in #92-61, Ethyl Petroleum Additives, by a vote of 7-0. (MN)

An Order, directing the Petitioner to file another status report with the Clerk of the Board and the assigned Hearing Officer on or before February 18, 1994, discussing the progress in the matter, and directing the Petitioner to file the appropriate motion on or before February 18, 1994, to address the expiration of the stay in the proceedings which is due to expire on March 15, 1994, was adopted in #92-105, Weyerhaeuser Company, by a vote of 7-0. (CAM)

An Order, granting the Agency until March 18, 1994 to file the Agency Record, was adopted in #92-112, James River Paper Company, by a vote of 7-0. (MMcF)

An Order, directing the parties to file a status report on or before April 7, 1994, in the event the appeal has not been dismissed, was adopted in #92-175, Olin Corporation, by a vote of 7-0. (RCF)

An Order, directing the parties to file a status report with the Board on or before March 21, 1994, was adopted in #93-28, RTC Industries, by a vote of 7-0. (ED)

An Order, directing the parties to submit status reports to be received by the Board and the hearing officer no later than January 17, 1994, was adopted in ##93-45, -46, St. Louis Auto Shredding, by a vote of 7-0. (RCF)

An Order, granting the Agency's motion to file its brief instant, was adopted in ##93-60, -61, Industrial Salvage, by a vote of 7-0. (RCF)

An Order, directing the parties to file additional status reports on or before April 22, 1994, was adopted in #93-77, Highland Park School District #108, by a vote of 7-0. (ED)

An Order, withdrawing Sproule Construction Company as a party, changing the case caption to reflect the withdrawal of Sproule, granting Petitioner's motion for an extension of time until 21 days from the date of the Order, to respond to the Agency's motion for summary judgment, and directing the Hearing Officer to respond to the remaining discovery motions at the appropriate time, after consultation with the parties, was adopted in #93-104, Griffin Service, by a vote of 7-0. (MN)

An Order, granting the Petitioner's motion to cite additional authority, and an Agency motion for reconsideration were granted, and upon reconsideration, the Board reaffirmed its October 21, 1993, Opinion and Order finding that the Agency may not reconsider its final deductibility determination, in #93-108, Fiatallis North American. (MN)

An Order, vacating a December 7, 1993 Hearing Officer order, advising the parties that a hearing must be held, absent a waiver of the decision deadline, no later than February 1, 1994, that the hearing will go forward on the merits of the case, and absent a waiver of the decision deadline, briefs will be due February 4, 1994, and further advising the parties that failure to proceed on the merits will result in a dismissal for failure to prosecute the appeal, was adopted in #93-121, Gunite Corporation, by a vote of 7-0. (GTG)

An Order, directing the parties to file a status report with the Board on or before February 4, 1994, accompanied by an additional waiver of the decision deadline, if the parties are not ready to proceed to hearing at that time, was adopted in #93-122, EMRO Marketing Company, by a vote of 7-0. (ED)

An Order directing the parties to file status reports with the Board no later than February 18, 1994, was adopted in #93-137, Safety-Kleen Corporation (Caseyville Facility), by a vote of 7-0. (ED)

An Order, reluctantly granting the Petitioner's motion for leave to file its brief instanter, noting that the Petitioner's brief as filed does not have pages numbered 11 and 12, and is apparently missing text at this point, and advising the Petitioner that the Board would allow the Petitioner an opportunity to file a corrected brief only upon the filing of a waiver of the decision deadline, was adopted in #93-142, HACO, Inc., by a vote of 6-0. M. Nardulli abstained. (RCF)

An Order, construing attorney, Frank Tighe's "motion for voluntary dismissal of the action, as to all parties and all claims," filed on behalf of Complainant, Frank Owoc, as a motion for voluntary dismissal of Frank Owoc solely, and accordingly granting the motion, and recaptioning the case with Joseph Schrantz, Charles Hullihan, and Elizabeth Stearns as the Complainants, was adopted in #93-161, Joseph A. Schrantz et al., by a vote of 7-0. (CAM)

An Order, denying Petitioners' motion for leave to supplement the record, granting the Residents Against a Polluted Environment's motion for leave to file an amicus brief, granting the Petitioner until January 11, 1994, to file its reply to the amicus brief, and noting that the Agency's motion to strike the Petitioner's brief

was not ripe for Board consideration and will be taken with the case-in-chief, was adopted in #93-162, Wilmer Brockman, Jr., by a vote of 7-0. (GTG)

An Order, granting the Agency an extension of time until April 1, 1994 to file the Agency record, and directing the parties to file a status report with the Board on or before March 1, 1994, was adopted in #93-174, Applied Composites Corporation, by a vote of 7-0. (MN)

An Order, granting the Respondent's motion for leave to file its Amended Answer to counts XIV and XVI through XX of the complaint, was adopted in #93-186, Emco Chemical Distributors, by a vote of 7-0. (RCF)

An Order, granting the Agency's motion to file a supplement to the Agency Record, was adopted in #93-195, City of Herrin, by a vote of 7-0. (GTG)

By a vote of 7-0, the Board, on its own motion, dismissed Complainants Gary and Valerie Braun, and Karen Nuzzo, for failure to enter their appearances pursuant to the Hearing Officer's Order and the Board's Procedural Rules at 35 Ill. Adm. Code 101.107(a), and directed the Clerk of the Board to correct the caption to reflect the filed appearances, in #93-204, Mark and Jeanne Doruff et al.. (CAM)

An Order, granting an Agency motion to file the Record instanter, was adopted in #93-213, Texaco Refining & Marketing, by a vote of 7-0. (JTM)

An Order, granting the Agency an extension of time until January 31, 1994, to file the Agency Record, was adopted in #93-215, Marvin Damron, by a vote of 7-0. (GTG)

An Order, granting the Styrene Information and Research Center's motion to stay until March 3, 1994, was adopted in R90-1(D), Toxic Air Contaminants List, Styrene, by a vote of 7-0. (CAM)

An Order, reluctantly denying the Agency's motion to dismiss, and advising the Agency that the Board will proceed with the correction under Section 28.2 of the Illinois Environmental Protection Act, was adopted in R93-26, Amendments to the New Source Review Rules, by a vote of 7-0. (GTG)
