December 20, 1977 Chicago, Illinois

An Opinion and Order was adopted in #75-83, Zeigler Coal by a vote of 4-0, Mr. Young abstained.

An Order was adopted in the matter of R73-11, -12, NPDES Amendments by a vote of 5-0.

A Motion to reopen in #76-114, Broverman was denied by a vote of 5-0. Dr. Satchell will prepare the Order.

Motion to Dismiss in #76-283, White Fence was denied and the proceedings were stayed by a vote of 4-1, Mr. Young dissented. Mr. Dumelle will prepare an Order.
