The Attorney General has brought a case against Gould Transportation Services, Inc, d/b/a Gould Bus Services for violating State pollution control rules. On February 27, 2025, the parties filed a stipulation and proposal for settlement. The parties agree that a hearing is unnecessary, and in accordance with State law, have requested that the settlement be adopted without holding a public hearing. GRACE PERIOD REGISTRATION & VOTING

If you are not registered to vote by the voter registration deadline of March 4, 2025, but you are a qualified resident of Douglas County, you may register to vote in person in the County Clerk's Office located on the 2nd floor of the Courthouse, Tuscola, Illinois and once registered must vote in person at that same time in the County Clerk's office.

FIRST DAY: MARCH 5, 2025
LAST DAY: APRIL 1, 2025

EARLY VOTING

This allows a voter to make application for a ballot and vote without having to be absent from the County on Election Day.

Registered voters may vote early in the County Clerk's Office from 8:30 A.M. to 4:30 P.M., Monday through Friday.

EARLY VOTING BEGINS: FEBRUARY 20, 2025
