RESOLUTION AND ORDER OF THE BOARD (by J. Theodore Meyer):

This matter comes before the Board upon a September 30, 1986 notice (51 Fed. Reg. 34904) published by the United States Environmental Protection Agency (USEPA) of the promulgation of an amendment to the National Emission Standards for Hazardous Air Pollutants (NESHAPS).

Subpart A: National Emission Standards for
Hazardous Air Pollutants; General Provisions,
40 CFR 61 (35 Ill. Adm. Code 231.110)

Subpart F: National Emission Standards for
Hazardous Air Pollutants; Vinyl Chloride,
40 CFR 61 (35 Ill. Adm. Code 231.160)

Subpart V: National Emission Standards for
Hazardous Air Pollutants; Equipment Leaks,
40 CFR 61 (35 Ill. Adm. Code 231.320)

Pursuant to Section 9.1 of the Environmental Protection Act, the Board is required to adopt amendments "in substance identical" to the federal NESHAPS amendments. The Board will do so through incorporation by reference of the federal amendment as a peremptory amendment. The Board will also update the CFR reference to the 1985 edition.

ORDER

The Board hereby adopts the following amendments to Title 35: Environmental Protection Subtitle B: Air Pollution; Chapter I: Pollution Control Board; Part 231: National Emission Standards for Hazardous Air Pollutants:

SUBPART A: GENERAL PROVISIONS

Section 231.110 General Provisions

The Board incorporates by reference 40 CFR 61, Subpart A (1985), as amended at 50 Fed. Reg. 46284, November 7, 1985; as amended at

51 Fed. Reg. 11021, April 1, 1986; as amended at 51 Fed. Reg. 34904, September 30, 1986.

SUBPART F: VINYL CHLORIDE

Section 231.160 Emission Standard for Vinyl Chloride

The Board incorporates by reference 40 CFR 61, Subpart F (19825); as amended at 51 Fed. Reg. 34904, September 30, 1986.


SUBPART V: EQUIPMENT LEAKS (Fugitive Emission Sources)

Section 231.320 Equipment Leaks (Fugitive Emission Sources)

The Board incorporates by reference 40 CFR 61, Subpart V (19845) ~~as amended at 49 Fed. Reg. 38946, October 27, 1984,~~ as amended at 51 Fed. Reg. 34904, September 30, 1986.
