DEAR CLERK GUNN:

PLEASE BE ADVISED THAT OUR FACILITY LOCATED IN VIRDEN, ILLINOIS HAS BEEN
CLEANED AND SWEEPED. THE MINISTRY PURCHASED THE NURSING HOME TO BUILD A
SENIOR CITIZENS ASSISTED CARE LIVING FACILITY.

WE MET STEVEN C. TOWNSEND ON JANUARY 09, 04 AT OUR OFFICE FOR THE MINISTRY
ON 1222 WEST JACKSON STREET IN AUBURN, ILLINOIS. MR. TOWNSEND ADVISED US
TO PICK UP AND SWEEP UP ANY DEBRIS THAT WAS AROUND THE DUMPSTER AREA. WE
SENT MEN FROM OUR CONGREGATION AND THEY ~~BY~~ MY REQUEST REMOVE AND SWEEPED THE
AREA.

I HAD NO KNOWLEDGE OF ANY THING OTHER THAN THAT. IN REVIEWING A SKETCH THERE
WAS SOME DEBRIS ON THE SOUTHWEST CORNER MARKED 003. WE HAVE SENT MEN ~~DOWN~~ THIS
DAY TO REMOVE ALL DEBRIS.

MR. STEVEN C. TOWNSEND SAW THAT THE ORIGINAL PILE OF DEBRIS WHICH CONSISTED
OF INSULATION CEILING TILE, FLOOR TILE AND SOME METAL STUDS WERE ALL DISPOSED
OF AND HAULED AWAY.

THE MINISTRY WILL HAVE SEVERAL MORE DUMPSTER LOADS OF MATERIAL THAT WILL BE
REMOVED OUT OF THIS BUILDING BEFORE WE START RECONSTRUCTION. WE WILL CERTAINLY
MAKE SURE ALL DEBRIS IS SWEEPED UP AND HAULED OFF ON EACH TRIP TO THE LAND FILL.

WE WILL ALSO TAKE PICTURES OF EVERY LOAD THAT WE LOAD AND HAUL OFF. IF ANY
THING NEEDS TO BE ADDRESSED PERTAINING TO THIS WE WOULD CERTAINLY GO WITH FIELD
REPRESENTATIVES SUCH AS MR. STEVEN C. TOWNSEND AND FIND OUT FOR SURE WHAT WE NEED
TO DO.

WE WILL CERTAINLY WORK WITH YOUR AGENCY IN ANY WAY TO MAKE SURE THERE ARE
NO EPA PROBLEMS ON OUR ASSISTED CARE LIVING FACILITY FOR THE SENIOR CITIZENS
OF THE VIRDEN AREA.
