#### **JURISDICTION**

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2002).

#### **FACTS**

- 1. That Earl and Norma Martin ("Respondents") are the present owners and operators of a facility located at County Road 2500 North, Rio Township, Knox County, Illinois. The property is commonly known to the Illinois Environmental Protection Agency as the Martin Property.
- 2. That said facility is an open dump operating without an Illinois Environmental Protection Agency Operating Permit and is designated with Site Code No. 0958145002.
- 3. That Respondents, Earl and Norma Martin, have owned and operated said facility at all times pertinent hereto.
- 4. That on May 7, 2004, Jeff Port of the Illinois Environmental Protection Agency's Peoria Regional Office inspected the above-described facility. A copy of his inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

#### **VIOLATIONS**

Based upon direct observations made by Jeff Port during the course of his May 7, 2004 inspection of the above-named facility, the Illinois Environmental Protection Agency has determined that Respondents have violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

- (1) That Respondents caused or allowed the open dumping of waste in a manner resulting in litter, a violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1) (2002).
- (2) That Respondents caused or allowed the open dumping of waste in a manner resulting in deposition of waste in standing or flowing waters, a violation of Section 21(p)(4) of the Act, 415 ILCS 5/21(p)(4) (2002).
- (3) That Respondents caused or allowed the open dumping of waste in a manner resulting in deposition of general construction or demolition debris or clean construction or demolition debris, a violation of Section 21(p)(7) of the Act, 415 ILCS 5/21(p)(7) (2002).

#### **CIVIL PENALTY**

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5) (2002), Respondents are subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of <u>Four Thousand Five Hundred Dollars (\$4,500.00)</u>. If Respondents elect not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than <u>July 30, 2004</u>, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondents elect to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2002), and if the Illinois

Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondents shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the One Thousand Five Hundred Dollar (\$1,500.00) statutory civil penalty for each violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1) (2002), if Respondents fail to petition or elect not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondent's check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Along with payment, Respondents shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondents from the date payment is due up to and including the date that payment is received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondents in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

### PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondents have the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2002). If Respondents elect to contest this Administrative Citation, then Respondents shall file a signed Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondents.

Statutory and regulatory references herein are provided for convenience only and should not be construed as legal conclusions of the Agency or as limiting the Agency's statutory or regulatory powers. Requirements of some statutes and regulations cited are in summary format. Full text of requirements can be found in references listed in 1. and 2. above.
- 4. The provisions of subsection (p) of Section 21 of the [Illinois] Environmental Protection Act shall be enforceable either by administrative citation under Section 31.1 of the Act or by complaint under Section 31 of the Act.
- 5. This inspection was conducted in accordance with Sections 4(c) and 4(d) of the [Illinois] Environmental Protection Act: 415 ILCS 5/4(c) and (d).
- 6. Items marked with an "NE" were not evaluated at the time of this inspection.

#### Narrative

On May 5, 2004, DLPC/FOS-Peoria received two complaints concerning the deposition of demolition waste into trenches dug on a property near Rio owned by Earl and Norma Martin. According to the complainants, Mr. Martin operates a demolition business (Martin Landscaping) and the demolition debris was from homes in Galesburg. The City of Galesburg had hired Mr. Martin to demolish the homes. The complaints were assigned numbers C-2004-056-P and C-2004-057-P.

On May 7, 2004, I (Jeff Port) performed an inspection at the Martin property. The property is located on County Road 2500 North. The complainants stated that the dump area was not visible from the road, but was down a dirt lane to the south. I arrived at the site at 10:20 AM. I was accompanied by Dawn Ingold, DLPC/FOS-Peoria. The weather was overcast and warm, approximately 70 °F. It had rained the previous evening and standing water was present throughout the area. We located the dirt lane and observed tire tracks in the mud that appeared to be new. As we drove down the lane we observed a large area to the east along a tree line where soil had been recently disrupted. Piles of demolition debris were also present here. As we looked toward the south we could see some vehicles and some heavy equipment. We proceeded to this area. When we arrived at this area, we observed a dozer and a backhoe operating. We quickly exited our vehicle and approached the equipment. A large trench appeared to have been dug in the ground. Demolition debris was present in the trench. A large pile of soil was located directly south of the trench. It appeared that the two men operating the equipment were covering up the demolition debris with the soil from the pile. I was able to get the attention of one of the men. He turned off his engine and asked what I wanted. I asked the man if Mr. Martin was available. The man told us that Mr. Martin was not on site. I introduced myself, explained that we were investigating complaints of dumping and burying of waste from demolished homes in Galesburg. The man got off his dozer and waved to the other man. Both men then approached us. I asked the first man his name. He said that he was Rex Carlson an employee of Mr. Martin. The other man identified himself as John Gerk. I explained to the men that what they were doing was in violation of several sections of the Illinois Environmental Protection Act and the Regulations. Mr. Gerk said he would attempt to contact Mr. Martin by cell phone. As he did I began photographing the site. Photographs P1 through P4 show the trench containing the demolition debris. Photographs P7 through P11 were taken along the edge of a ravine to the southeast of the trench area. A variety of waste was present here including demolition debris, domestic waste, and landscape waste. The soils in this area appeared to have been disrupted recently. Photographs P12 through P19 and P36 show an area to the west of the ravine where soils also had been disrupted. It appeared that waste had been buried in this area as several pieces of demolition debris and domestic waste were sticking out of the surface of the soil. Photographs P20 through P22 show the trench and the soil pile to the south. When I returned to the trench, I was told that Mr. Martin was on vacation and was unable to be reached. Mr. Carlson and Mr. Gerk said that I could contact him on Monday. I asked them if they had any information concerning where the demolition debris had come from. Neither of the men were willing to give me any further information. I suggested that they both stop covering the waste material and that they leave the site. I told them that I needed to inspect the rest of the site.

We then proceeded with the inspection of the property. We walked to the southern portion of the property. Here we found several areas where waste had been dumped. Some of the waste had been placed into a creek running through the property. The waste included demolition debris, scrap metal, domestic waste, and landscape waste. Photographs P23 through P35 show the waste in these areas. Photographs P34 and P35 show waste dumped in the water.

We next proceeded back toward the north. Here we encountered several junk vehicles scattered throughout the property. Many of the vehicles had Martin Landscaping logos on their doors. Photograph P37 shows an old water heater. Photograph P38 shows a lead acid battery. Several waste tires were seen throughout the area. Photographs P39 through P47 shows some of the tires. Photograph P43 shows a tire that was holding water. Both inspectors observed mosquito larvae swimming in the water. Photograph P48 and P49 show empty underground storage tanks present on site. As we finished photographing this area of the property, we observed Mr. Carlson and Mr. Gerk sitting in a truck at the entrance to this area. We entered our vehicle and began to leave this area. Mr. Carlson and Mr. Gerk followed us.

We stopped at an area to the north of the previously investigated area. I wanted to examine the area that we observed upon entering the property. Photograph P50 shows a pile of demolition debris. I walked down the east side of the tree line proceeding toward the southeast. I observed several areas along the tree line where waste was poking up through the soil. It appeared that several loads of waste material had been dumped and buried in this area. Photographs P51 through P61 show this area. Both domestic waste and demolition debris could be seen intermingled with the soil. Photograph P60 shows an area where burned material had been dumped. After photographing this area we proceeded north on the dirt lane and left the property. Mr. Carlson and Mr. Gerk followed us as we left the site at approximately 11:30 AM.

Photograph locations are depicted on the accompanying site maps. Based upon these inspections, the following violations were observed and are indicated on the accompanying checklists.

1. Pursuant to Section 12(a) of the {Illinois} Environmental Protection Act (415 ILCS 5/12(a)), no person shall cause or threaten or allow the discharge of any contaminants into the environment in any State so as to cause or tend to cause water pollution in Illinois, either alone or in combination with matter from other sources, or so as to violate regulations or standards adopted by the Pollution Control Board under this Act.

A violation of Section 12(a) of the {Illinois} Environmental Protection Act (415 ILCS 5/12(a)) is alleged for the following reason: By allowing the accumulation of waste at the site, Earl and Norma Martin threatened water pollution in Illinois.

2. Pursuant to Section 12(d) of the {Illinois} Environmental Protection Act (415 ILCS 5/12(d)), no person shall deposit any contaminants upon the land in such place and manner so as to create a water pollution hazard.

A violation of Section 12(d) of the {Illinois} Environmental Protection Act (415 ILCS 5/12(d)) is alleged for the following reason: By allowing the accumulation of waste at the site, Earl and Norma Martin created a water pollution hazard.

3. Pursuant to Section 21(a) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(a)), no person shall cause or allow the open dumping of any waste.

A violation of Section 21(a) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(a)) is alleged for the following reason: Earl and Norma Martin caused or allowed the open dumping of waste at the site.

4. Pursuant to Section 21(c) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(c)), no person shall Abandon any vehicle in violation of the "Abandoned Vehicles Amendment to the Illinois Vehicle Code".

A violation of Section 21(c) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(c)) is alleged for the following reason: Earl and Norma Martin caused or allowed the abandonment of vehicles in violation of the "Abandoned Vehicles Amendment to the Illinois Vehicle Code".

5. Pursuant to Section 21(d)(1) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(d)(1)), no person shall conduct any waste-storage, waste-treatment, or waste-disposal operation without a permit granted by the Agency or in violation of any conditions imposed by such permit.

A violation of Section 21(d)(1) is alleged for the following reason: Earl and Norma Martin conducted a waste-disposal operation at the site without a permit granted by the Agency.

6. Pursuant to Section 21(d)(2) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(d)(2)), no person shall conduct any waste-storage, waste-treatment, or waste-disposal operation in violation of any regulations or standards adopted by the Board under this Act.

A violation of Section 21(d)(2) is alleged for the following reason: Earl and Norma Martin conducted a waste-disposal operation in violation of Section 812.101(a) of the Regulations.

7. Pursuant to Section 21(e) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(e)), no person shall dispose, treat, store or abandon any waste, or transport any waste into this State for disposal, treatment, storage or abandonment, except at a site or facility which meets the requirements of this Act and of regulations and standards thereunder.

A violation of Section 21(e) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(e)) is alleged for the following reason: Earl and Norma Martin conducted a waste-disposal operation at a site that does not meet the requirements of Sections 12(a), 12(d), 21(a), 21(c), 21(d)(1), and 21(d)(2) of the Act and Section 812.101(a) of the Regulations.

8. Pursuant to Section 21(p)(1) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(p)(1)), no person shall, in violation of subdivision (a) of this Section, cause or allow the open dumping of any waste in a manner which results in litter.

The prohibitions specified in this subsection (p) shall be enforceable by the Agency either by administrative citation under Section 31.1 of this Act or as otherwise provided by this Act. The specific prohibitions in this subsection do not limit the power of the Board to establish regulations or standards applicable to open dumping.

A violation of Section 21(p)(1) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(p)(1)) is alleged for the following reason: The open dumping of waste was caused or allowed in a manner which resulted in litter.

9. Pursuant to Section 21(p)(4) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(p)(4)), no person shall, in violation of subdivision (a) of this Section, cause or allow the open dumping of any waste in a manner which results in the deposition of waste in standing or flowing waters.

A violation of Section 21(p)(4) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(p)(4)) is alleged for the following reason: The open dumping of waste was caused or allowed in a manner which resulted in the deposition of waste in standing or flowing waters.

10. Pursuant to Section 21(p)(7) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(p)(7)), no person shall, in violation of subdivision (a) of this Section, cause or allow the open dumping of any waste in a manner which results in the deposition of general construction or demolition debris; or clean construction or demolition debris.


A violation of Section 21(p)(7) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(p)(7)) is alleged for the following reason: The open dumping of waste was caused or allowed in a manner which resulted in the deposition of general construction or demolition debris or clean construction or demolition debris as defined in Section 3.160(b) of this Act.


11. Pursuant to Section 55(a)(1) of the {Illinois} Environmental Protection Act (415 ILCS 5/55(a)(1)), no person shall cause or allow the open dumping of any used or waste tire.

A violation of Section 55(a)(1) of the {Illinois} Environmental Protection Act (415 ILCS 5/55(a)(1)) is alleged for the following reason: The open dumping of waste tires was caused or allowed.


12. Pursuant to Section 812.101(a), all persons, except those specifically exempted by Section 21(d) of the Illinois Environmental Protection Act (Act) (Ill. Rev. Stat. 1991, ch. 111 1/2, par. 1021(d)) [415 ILCS 5/21(d)] shall submit to the Agency an application for a permit to develop and operate a landfill. The applications must contain the information required by this Subpart and by Section 39(a) of the Act, except as otherwise provided in 35 Ill. Adm. Code 817.


A violation of Section 812.101(a) is alleged for the following reason: Earl and Norma Martin operated a landfill at the site without submitting an application for a permit to the Agency.




