Protection Agency. In support of this Petition, the City states as follows:

- 1. That the City of Salem is the permitted owner, Roger Kinney is the permitted operator and Dick Brown and Jason Bruce are the certified operators of the Salem Municipal Landfill #2, located at 900 East Lake Street, Salem, Marion County, Illinois.
- 2. That the Landfill is a municipal solid waste and non-hazardous special waste landfill that is used for the disposal of residential, commercial and industrial waste. The Landfill's facility identification number is 1218130007 and operates under Illinois Environmental Protection Agency Permit No. 1995-178-LFM.

- That Respondents have owned and/or operated said facility at all times pertinent hereto.
- 4. That the Respondents believe the Administrative Citation was improperly issued because the Respondents did not cause or allow the alleged violations listed below or were in part due to uncontrollable circumstances:
 - A. That Respondents conducted a sanitary landfill in a manner which resulted in uncovered refuse remaining from any previous operating day or at the conclusion of any operating day, unless authorized by permit, a violation of Section 21(o)(5)(2002) of the Act, 415 ILCS 5/21(o)(5)(2002).
 - B. That Respondents conducted a sanitary landfill operation in a manner which resulted in the failure to collect and contain litter from the site by the end of the operating day, a violation of Section 21(o)(12) of the Act, 415 ILCS 5/21(o)(12)(2002).
- 5. In addition, Respondents state that they had a mistaken understanding with respect to the type of materials authorized by the above-referenced permit to be used as Alternative Daily Cover Materials.

WHEREFORE, for the above reasons, Respondents, CITY OF SALEM, ROGER.

KINNEY, DICK BROWN and JASON BRUCE, pray that this Board dismiss the

Administrative Citation filed herein by the Illinois Environmental Protection Agency and grant all other relief just and proper in the premises.
