# STIPULATION OF SETTLEMENT AND DISMISSAL OF RESPONDENT'S PETITION FOR ADMINISTRATIVE REVIEW

NOW COMES the Complainant, the County of Jackson, ("County"), by and through its attorney, Assistant State's Attorney, Daniel Brenner, and the Respondent, Frank Stonemark, by and through his attorney, Gregory A. Veach, and pursuant to Sections 31.1 and 42(b)(4-5) of the Illinois Environmental Protection Act ("Act"), 415 ILCS 5/31.1 and 42(b)(4-5) (2002), and Sections 103.300 through 103.306 of the Illinois Pollution Control Board's ("Board") Rules and Regulations, 35 III.

Adm. Code 103.300 et. seq., the parties hereby enter into this STIPULATION OF SETTLEMENT AND DISMISSAL OF RESPONDENT'S PETITION FOR ADMINISTRATIVE REVIEW ("Agreement"), and in support hereof, the parties respectfully state as follows:

- 1. On January 7, 2004, Don Terry, a Solid Waste Inspector, for the Jackson County Health Department, conducted an inspection of a facility owned and operated by the Respondent. The facility is located in Section 15 of Pomona Township, Jackson County, and is designated with a Site Code No. 0778125012.
- 2. On or about January 23, 2004, the County served the Respondent with Administrative Citation No. AC 04-43, alleging therein that the Respondent had caused or allowed open dumping

at his facility on January 7, 2004, in a manner which resulted in the following occurrences: (1) litter, a violation of 415 ILCS 5/21(p)(1) (2002); and (2) deposition of general construction or demolition debris; or clean construction or demolition debris, a violation of 415 ILCS 5/21 (p)(7)(2002).

- 3. On or about March 30, 2004, the Respondent filed a Petition for Review contesting the administrative citation.
- 4. In an effort to resolve this matter without the need for a hearing, the parties have engaged in settlement negotiations and have reached this Agreement and hereby tender it to the Board for approval, the terms and conditions of which are as follows:
  - a. Respondent admits that he caused or allowed open dumping resulting in litter, a violation of 415 ILCS 5/21(p)(1) (2002). Respondent agrees to pay the statutory civil penalty of \$1,500.00 pursuant to 415 ILCS 5/42(b)(4-5) (2002).
  - b. Respondent agrees to pay the statutory civil penalty within thirty (30) days following the Board's final order in this matter. Payment shall be made to the Jackson County Treasurer as payee, Jackson County Courthouse, Murphysboro, Illinois 62966.
  - c. Respondent agrees to diligently comply with, and shall cease and desist from further violation of the Act, 415 ILCS 5/1 et. seq. (2002), and the Board's rules and regulations, 35 Ill. Adm. Code Subtitles A through H.
  - d. The waste located at the site that was the subject of this administrative citation has been removed and properly disposed of.
  - e. Respondent's Petition for Review filed with the Board on or about March 30, 2004, shall be dismissed.

WHEREFORE, the parties request that the Board accept this Agreement and issue an order consistent with its terms and conditions.
