The Village of Bensenville (12 South Center Street, Bensenville, IL. 60106) filed a Petition for Adjusted Standard with the Illinois Pollution Control Board on January 3, 2005, which Petition is docketed as AS 05-02. This Petition seeks an adjusted standard from the Board's groundwater quality standards (35 III. Adm. Code 620.410) as they apply to levels of chloride and lead in groundwater under the former Bensenville Landfill ("Site") located at the intersection of Interstate 294 and Grand Avenue. The Site is a former construction debris landfill which the Village has developed into a golf course. Bensenville has documented that levels of chloride and lead in the groundwater at the southeastern corner Site are higher than the applicable groundwater auality standards primarily due to run-off of road salt from the adjacent highways and sources other than the Site.
