This notice is hereby given that Stericycle, Inc., 3801 Laramie Street, Cicero, Illinois filed on September 5, 2007 a Petition for Adjusted Standard from Illinois Administrative Code Title 35, § 1422.111(B)(1); § 1450.105(A)-(B); § 1450.200(E) with the Illinois Pollution Control Board, Docket No. AS 08-2. Stericycle has petitioned for an adjusted standard that would permit it to weigh and record the weight of each load of Potentially Infectious Medical Waste (PIMW) received by its transfer station at 3801 S. Laramie Street, Cicero, Illinois 60804 at its Clinton, Illinois or Sturtevant, Wisconsin facilities which transport PIMW to the Cicero facility instead of at the Cicero facility, because the weight data collected at the Clinton and Sturtevant facilities is more accurate, is made contemporaneously with the receipt of the PIMW at each facility, is recorded daily and is transmitted daily to the Stericycle's headquarters in Illinois.

Any person may cause a public hearing to be held in the above-described adjusted standard proceeding by filing a hearing request with the Illinois Pollution Control Board within 21 days after the date of the publication of this notice.
