



MOTION FOR EXTENSION OF TIME TO FILE AMENDED PETITION

Pursuant to 35 Ill. Adm. Code §§ 101.500, 101.522, and 102.402, Petitioner Stericycle, Inc. ("Stericycle") hereby moves the Illinois Pollution Control Board (the "Board") for an extension of time in which to file an Amended Petition as directed by the October 18, 2007 Order of the Board (the "Order") in this matter.

Stericycle received the Order on October 22, 2007 by U.S. Mail, four days after it was issued. The Order requested additional information from Stericycle so that the Board could act on Stericycle's Petition for an Adjusted Standard. Indeed, the Order identified eight informational deficiencies that the Board requested Stericycle address in an Amended Petition. Many of the informational deficiencies also contained numerous subparts. The Order directed Stericycle to file its Amended Petition addressing the informational deficiencies within 30 days of the date of the Order, or by November 17, 2007.


Since receipt of the Order, Stericycle has worked diligently to gather the information requested by the Order. However, due to the number of requests and the time it has taken to collect the necessary information to address each of the issues raised in the Order, Stericycle needs additional time to prepare its response in an Amended Petition. Accordingly, it requests a

modest amount of time, until December 21, 2007, in which to develop and file its Amended Petition.

This request is made in good faith and is Stericycle's first request for extension of time. This extension will not adversely prejudice any party nor impede the progress of the underlying Petition. Stericycle has contacted counsel for the Illinois Environmental Protection Agency, and they have no objection to this extension of time.

Therefore, for good cause shown, Stericycle respectfully moves the Board for an extension of time in which to file its Amended Petition to and including December 21, 2007.
