

ADMINISTRATIVE CITATION


NOW COMES the Complainant, the Illinois Environmental Protection Agency ("Illinois EPA"), by and through its attorney, Assistant Counsel Michelle M. Ryan, pursuant to 35 Ill. Adm. Code 108.402, and respectfully states as follows:

- (1) On September 30, 2008, the Illinois EPA issued an Administrative Citation to Respondent, Mid-America Machinery Co., based on an inspection conducted on August 14, 2008.
- (2) On October 20, 2008, the Administrative Citation was sent back to the Illinois EPA from the United States Postal Service, as unclaimed.
- (3) Because Mid-America Machinery Co. was not timely served within 60 days as required by 415 ILCS 5/31.1(b), this Administrative Citation should be dismissed.

WHEREFORE, the Illinois Environmental Protection Agency requests that the Board dismiss the pending action against Mid-America Machinery Co.


