**NOTICE OF LIMITED WAIVER  
OF 120-DAY DECISION DEADLINE**

NOW COMES Petitioner, THE PREMCOR REFINING GROUP INC.

("Petitioner"), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), and hereby agrees to a limited waiver of the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board ("Board"), in the above-referenced proceeding, until October 21, 2010. In support of this Notice, the Petitioner states as follows:

1. On December 9, 2009, Petitioner reissued a Clean Air Act Permit Program Permit ("CAAPP") that was the subject of appeal in *The Premcor Refining Group Inc. v. Illinois Environmental Protection Agency*, PCB 07-30.

2. On January 27, 2010, Petitioner filed a Petition requesting a hearing on the Illinois Environmental Protection Agency's ("Illinois EPA") action to issue a CAAPP permit in a fashion that does not reflect the current applicable requirements or the current operation of the facility, and also filed a Motion to Stay Effectiveness of the CAAPP Permit.

3. On February 4, 2010, the Board accepted Petitioner's petition for hearing.

4. The current decision deadline is August 19, 2010.

5. Petitioner hereby voluntarily agrees to a limited waiver of the statutory 120-day decision deadline, until October 21, 2010, in order to conduct settlement negotiations in this matter.

WHEREFORE, Petitioner, THE PREMCOR REFINING GROUP INC., prays that the Illinois Pollution Control Board accepts this limited waiver of the statutory 120-day decision deadline until October 21, 2010, for final action on Petitioner's Petition for Review.
