              MS. CROWLEY: Good afternoon. My name is
```

- 1 Kathleen Crowley. The Hearing Officer assigned to this
- 2 regulatory proceeding. This is the first of two
- 3 presently scheduled hearings being conducted by the
- 4 Illinois Pollution Control Board in the matter of
- 5 Tenured Federally Enforceable State Operating Permit,
- 6 known as Fesop, Amendments to 35 Illinois
- 7 Administrative Code Section 201.162. And that is the
- 8 Pollution Control Board Docket R10-21.
- 9 Today's Hearing Board will begin its
- 10 receipt of testimony on the merits and the economic
- effects of the April 20, 2010 Regulatory Proposal
- 12 filed by the Illinois Environmental Protection Agency.
- 13 The Agency proposal would extend from five years to
- 14 ten years. The maximum term that the Agency could
- issue is a FESOP. The sole position of the air rules
- to be amended is Section 201.162.
- We have present today only the Court
- 18 Reporter, Board Representatives and Agency
- 19 Representatives. So we'll shorten up some of the
- usual opening remarks. All hearings before the Board
- 21 are transcribed by the Court Reporter you see with us
- 22 today. All witnesses will be sworn in by the Court
- Reporter prior to giving testimony. Any person may
- 24 ask questions of any witness giving testimony. Any

- 1 questions that may come from me or representatives of
- 2 the Board are intended not to reflect any conclusion
- on the merits, but simply to provide a complete record
- 4 for Board deliberation.
- 5 Seated to my immediate right is Board
- 6 Member, Carey Zalewski, the board member coordinating.
- 7 And seated to her right is Board Member, Gary
- 8 Blankenship. And at this point I'll ask you for your
- 9 appearance, Miss Doctors.
- MS. DOCTORS: My name is Rachel Doctors
- 11 representing the Illinois Environmental Protection
- 12 Agency.
- MS. CROWLEY: Before we begin with the
- 14 Agency's testimony, there is just a couple of items of
- 15 information that I need to answer into the record. The
- 16 Board accepted the Agency's proposal for hearing on
- May 6, 2010. The Board on June 17, 2010 authorized
- 18 first notice publication of the Rule without comments
- on the merits. This was published in the July 2, 2010
- 20 Illinois Register at 35 Illinois Register 8508. The
- 21 publication started a 45-day public comment under the
- 22 Administrative Procedure Act. First business day after
- the 45th day is August 16, 2010, which is the current
- 24 close comment date.

- 1 The first notice publication includes
- 2 the dates of today's hearing and the next hearing
- 3 scheduled for July 21st in Springfield. And the
- 4 publication also referenced the June 9, 2010 Hearing
- 5 Officer order setting deadlines for the prefiling of
- 6 testimony and addressing other procedural points.
- 7 On June 4, 2010 the Board submitted a
- 8 written request to the Department of Commerce and
- 9 Economic Opportunity known as DCEL. The Board
- 10 requested that it perform an Economic Impact Study as
- 11 provided for in Section 27 of the Environmental
- 12 Protection Act. The Board requested that DCEL provide
- any response to the request on or before June 30th.
- No written request has been received and no study has
- been filed.
- Section 27(b) requires the Board to hold
- a hearing on the economic impact of rules and any EcIS
- submitted and on any explanation DCEL provides for not
- 19 conducting an EcIS.
- 20 Section 24(b) allows the Board to
- 21 dovetail the economic impact hearing with any other
- 22 hearing. The DCEL EcIS issue will be addressed at the
- 23 next hearing on July 21st, although participants here
- today may address it as well if they care to.

- 1 The only testimony prefiled was that by
- 2 IEPA's Bob Bernoteit. So we may as well begin with
- 3 Mr. Bernoteit then.
- 4 MS. DOCTORS: I would ask that his testimony
- 5 be entered as if read.
- 6 MS. CROWLEY: First, could we have
- 7 Mr. Bernoteit sworn as a witness.
- 8 (WITNESS SWORN)
- 9 ROBERT BERNOTEIT,
- 10 called as a witness herein, after having been first
- 11 duly sworn, was examined and testified as follows:
- MS. CROWLEY: Is that acceptable to be as
- 13 read rather than delivered?
- MR. BLANKENSHIP: Yes.
- MS. ZALEWSKI: Yes.
- MS. CROWLEY: We'll mark the testimony
- submitted by Mr. Bernoteit on June 29, 2010 as Exhibit
- Number 1 in this proceeding or 10-11.
- 19 (WHEREUPON Exhibit 1 was
- 20 marked for identification)
- MS. DOCTORS: Would you like copies?
- MS. CROWLEY: I think we all do.
- MS. DOCTORS: I have one procedure thing that
- I need to get on the record.

- 1 MS. CROWLEY: Sure.
- MS. DOCTORS: I would like to indicate at the
- 3 time that at the completion of this rulemaking process
- 4 that the Agency would be submitting its rulemaking and
- 5 the package S&L to the UCPA as the state rules covering
- 6 permits for the -- that are federally enforceable.
- 7 MS. CROWLEY: Off the record for a second.
- 8 (DISCUSSION OFF THE RECORD)
- 9 MS. DOCTORS: The Agency, if the testimony
- 10 has been accepted and filed as Exhibit 1, then we're
- open for any questions that the Board may have.
- 12 EXAMINATION
- 13 BY MS. CROWLEY:
- 14 Q Your testimony indicates, as does the
- proposal, that the maximum term of the FESOP permit
- would be extended from five years to ten years.
- 17 Permits that I have seen in my career with the state
- have always included an expiration date. Would it be
- 19 correct to assume that these permits will also have an
- 20 expiration date listed on their face so that it knows
- 21 whether it has got a five-year permit or a ten-year
- 22 permit?
- 23 A They will continue to list the expiration
- 24 date. The only change is the expiration date would be

- 1 extended to ten years in the future rather than a
- 2 maximum of five years into the future.
- O Do you have any idea how -- well, strike
- 4 that.
- Do you have any range of, oh, cost that
- 6 you have heard of that sources expend for engineering
- 7 and consulting and lawyer fees in applying for FESOP
- 8 renewal permits?
- 9 A The renewal process is a simple
- 10 straightforward process. If the source has not had any
- 11 changes or is not proposing any changes as part of the
- 12 renewal. So it is a simple two-page application form.
- 13 I would estimate that the cost to prepare such a form
- 14 would not typically extend more than \$200.
- 15 Q The type of form we have seen before where
- 16 there is a checkoff, has anything changed in the
- 17 signature and the appropriate name of company and
- 18 signing officer, et cetera?
- 19 A That's correct.
- 20 Q I see at the fourth page of your testimony
- that you would expect that the workload of FESOP
- 22 renewals would increase by approximately ten percent
- within five years of adoption of the proposal?
- 24 A We would decrease by five percent.

- 1 Q And that -- I misspoke. And that would in
- decrease processing time and manpower, et cetera, et
- 3 cetera?
- 4 A That's correct.
- 5 Q As said in the testimony.
- 6 Members have any questions?
- 7 MS. ZALEWSKI: I have no other questions.
- MR. BLANKENSHIP: No.
- 9 MS. CROWLEY: Thank you very much,
- 10 Mr. Bernoteit.
- Did you have anything else that you
- wanted to present, Miss Doctors?
- MS. DOCTORS: That concludes the Agency's
- 14 comments. I would like to thank the Board members and
- 15 the Hearing Officer for their time.
- MS. CROWLEY: The next hearing, as I said
- earlier, is scheduled for July 21, 2010 in Springfield.
- 18 There doesn't seem to be a substantial interest in this
- 19 rulemaking. In the interest of travel and economy, the
- second hearing may be held by the board Springfield
- 21 base Hearing Officer Carroll Webb. We have done that
- 22 in other small rulemakings of this type. That would
- leave Member Zalewski to make the trip to Springfield
- 24 to see you.

- MS. ZALEWSKI: It is lovely this time of
- 2 year.
- MS. CROWLEY: Following the close of the
- 4 July 21st hearing, the Hearing Officer will set a date
- 5 for the close of public comment. As I said before, the
- 6 45-day first notice comment period required by the APA
- 7 began on July 2nd and ends August 16th. Section 102
- 8 108 (b) of the Board procedural rules also provides
- 9 that the Board will accept comments for 14 days after
- 10 the receipt of the hearing transcript or any other date
- 11 set by the Hearing Officer.
- 12 The Agency is requested to check
- calendars and be ready to suggest dates for the close
- of the public comment period on or after August 16th.
- We have been trying to expedite this proceeding in the
- interest of saving everyone money. And again whatever
- is a reasonable close comment period given the fact
- that we're on summer vacation season, et cetera.
- 19 We'll do what we can to accommodate you.
- If there is nothing else from anyone,
- seeing nothing then, thank you all for attending and
- 22 have a good trip back to Springfield. Thanks a lot.

STATEMENT OF REASONS

The Illinois Environmental Protection Agency ("Illinois EPA" or "Agency") hereby submits this Statement of Reasons to the Illinois Pollution Control Board ("Board") pursuant to Sections 10, 27, 28, and 39 of the Environmental Protection Act ("Act") (415 ILCS 5/10, 27, 28, and 39) and 35 Ill. Adm. Code 102.202(b)) in support of the attached proposed amendments. Included in this proposal are amendments to 35 Ill. Adm. Code Section 201.162. This proposal amends the most recent version of 35 Ill. Adm. Code Part 201, as found on the Board's website.

I. <u>ILLINOIS ENVIRONMENTAL PROTECTION AGENCY'S PROPOSAL</u>

a. Background - Federally Enforceable State Operating Permits

On December 17, 1992, the United States Environmental Protection Agency ("USEPA") approved the provisions of the Illinois EPA's Federally Enforceable State Operating Permit ("FESOP") program. USEPA stated that Illinois EPA's FESOP program met all five criteria for approving a state operating permit program as part of a State Implementation Plan ("SIP"). Specifically, the Illinois EPA must submit its permit program to USEPA for approval; terms of the permit and its renewal must be legally enforceable; the terms and conditions of the permit must be at least as stringent as any

other applicable limitation or requirement contained in the SIP or enforceable by the SIP or waive any requirements that are federally enforceable (e.g., standards established under section 111 or 112 of the Clean Air Act ("CAA")); the limitations, controls and requirements in the permit must be permanent, quantifiable and otherwise enforceable as a practical matter; and the permits must be issued pursuant to public participation. *Id.*

USEPA restated its approval of the Illinois EPA's FESOP program when it approved the Clean Air Act Permit Program ("CAAPP") pursuant to Section 39.5 of the Act. Subsection 3.3(c) of Section 39.5 of the Act, gives the Illinois EPA the authority to issue FESOPs for the purposes of limiting a sources potential to emit pursuant to the Illinois EPA's general authority to issue state permits under Section 39(a) of the Act.

The Board adopted regulations for implementation of issuing state air pollution control permits in 35 III. Adm. Code 201. Section 201.162 specifies the duration that permits can be issued as either subject to Section 201.169 (perpetual permits) or five years. This proposal seeks to extend the term of State operating permits from five to ten years. This proposal does not change the term of perpetual permits issued pursuant to Section 201.169 or CAAPP permits issued pursuant to Section 39.5 of the Act.

b. This Proposal

This proposal extends the maximum term that a FESOP may be issued from five to ten years. Currently, State operating permits, except for smaller source permits, may only be issued for five years or less. Under the proposal, the term that a FESOP could be issued would be extended from five to ten years at the discretion of the Illinois EPA. The Illinois EPA retains the discretion that it currently has under Section 201.162 to issue permits for a term that is shorter than the maximum. The term for CAAPP permits issued

pursuant to Section 39.5 of the Act, except for sources exempted from CAAPP pursuant to subsection 1.1 of Section 39.5 of the Act, would remain five years as required by statute. 415 ILCS 5/39.5(1.1). Owners or operators of sources not subject to CAAPP or requiring a FESOP would remain subject to the requirements of Section 201.169, which grants permits indefinitely. That Section requires that State permits only be renewed at the request of the Illinois EPA or if the circumstances underlying the permit change.

Two other states have adopted or are in the process of adopting rules extending the term of FESOPs from five to 10 years. The State of Indiana received final approval of their rule on October 6, 2009. 74 Fed.Reg. 51240. (Att. "A")

c. Implementation

The Illinois EPA has averaged 61 new FESOP applications each year since the year 2000 and 66 FESOP renewal applications each year over the last ten years. When these applications come in and are reviewed, at the discretion of the Illinois EPA, the permits will be granted for a term of 10 years. The Illinois EPA may choose to issue a FESOP for a term shorter than ten years. FESOPs that are issued for a term shorter than ten years include situations in which the source may have been out of compliance with the applicable requirements prior to issuance of the FESOP and need to perform additional performance testing to demonstrate or confirm compliance with the applicable requirements.

It is important to note that granting FESOPs for a longer term will not affect the implementation of air pollution control programs or enforcement of air quality standards in the State of Illinois. Sources must comply with all applicable requirements of the Board's rules or the Act, regardless of the length of a FESOP's term or the timing of its

issuance. FESOPs generally contain limits on the operations of the source, e.g., materials used and hours or operation, which effectively restrict the source's potential to emit. The Illinois EPA's program requires the permits to undergo public notice and be subject to public comments. A FESOP does not impact any previously or newly applicable substantive requirements of the Act, the Board's rules or the Clean Air Act ("CAA"), such as a new maximum achievable control technology standard under Section 112 of the CAA. Such requirements remain independently enforceable. Similarly, owners and operators of FESOPs will still need to meet all applicable requirements under the Act, including those related to new construction. Therefore, an extension of the term for an initial or a renewal of a FESOP from five to ten years does not delay an owner or operator's obligation to comply with all applicable requirements.

II. GEOGRAPHIC REGIONS AND SOURCES AFFECTED

The entire State of Illinois will be affected, as no single region contains all FESOP sources. The proposed regulations will affect all of the approximately 800 sources in Illinois that have either applied for or have obtained a FESOP. The industrial sectors in which these sources are categorized are on Att." B."

III. PURPOSE AND EFFECT OF THE PROPOSAL

The purpose of this proposal is to extend the maximum term that a FESOP may be issued from five to ten years. Currently, State operating permits, except for smaller source permits, may only be issued for five years or less. Under the proposal, the permit term would be extended up to ten years at the discretion of the Illinois EPA. The term for CAAPP permits issued pursuant to Section 39.5 of the Act, except for sources exempted from CAAPP pursuant to subsection 1.1 of Section 39.5 of the Act would remain 5 years

as required by statute. 415 ILCS 5/39.5(1.1).

This proposal will have a positive economic impact on affected sources by reducing time spent on permit renewal applications. This proposal will also reduce the costs to the Illinois EPA associated with the time and effect required for processing these permit renewal applications. While sources with FESOP permits represent only a small amount of emissions in Illinois, they require a large proportion of the Illinois EPA's permitting resources. The reduced frequency of these renewals will provide a significant time savings for the Illinois EPA. Within five years of adoption of this proposal, it would be anticipated that the workload of FESOP renewals would decrease by approximately ten percent.

IV. TECHNICAL FEASIBILITY AND ECONOMIC REASONABLENESS

As discussed above, the proposal imposes no new regulatory requirements on affected sources. The amendments to Section 201.162 merely extend the duration of FESOPs. The amendments are expected to reduce administrative costs of the permitting process for both the affected sources and the Illinois EPA. As this proposal imposes no new requirements or costs on affected sources, the proposal is both technically and economically feasible.

V. <u>COMMUNICATION WITH INTERESTED PARTIES</u>

These amendments are being proposed after representatives of industry and environmental groups have had an opportunity to review the proposed changes and provide comments to the Illinois EPA. The Illinois EPA sent electronic mails to the affected owners and operators on January 22, 2010, as well as posting a notice on its website. The Illinois EPA received three oral comments. (Att. "C") Two comments

were in favor and one comment had a concern. Therefore, it is the Illinois EPA's understanding that there are no specific issues identified by interested parties and that this rulemaking is not highly controversial.

VI. <u>SYNOPSIS OF TESTIMONY</u>

Currently, the Illinois EPA plans to call Robert Bernoteit, Unit Manager of the FESOP Unit of the Permit Section of the Bureau of Air. Mr. Bernoteit will testify about the amendments to the rules and will assist in answering questions. Written testimony will be submitted prior to hearing in accordance with the Board's procedural rules.

VII. PUBLISHED STUDY OR RESEARCH REPORT

No published study or research report was used in developing the proposed amendments to 35 Ill. Adm. Code Section 201.162.

VIII. THE ILLINOIS EPA'S PROPOSAL

Section 201.162 Duration

Illinois EPA is proposing to is to extend the maximum term that a FESOP may be issued from five to ten years.

IX. <u>CONCLUSION</u>

For the reasons stated above, the Illinois EPA hereby submits this regulatory proposal and respectfully requests that the Board expeditiously adopts these rules for the State of Illinois.

Indiana submitted this rule revision for approval on December 19, 2007. FESOPs apply to non-major sources that obtain enforceable limits to avoid being subject to certain Clean Air Act (Act) requirements, including the Title V operating permit program. Neither the Act nor its implementing regulations specify a permit-term requirement for FESOPs. This rule revision will provide relief to Indiana's resource burden of processing permit renewals. It will also allow the Indiana Department of Environmental Management to devote more resources to major source Title V permitting actions and permit modifications for both Title V and FESOP sources.

SUPPLEMENTARY INFORMATION:

A. Background

The Federal Acquisition Regulation (FAR) 52.232-10, Payments under Fixed-Price Architecture-Engineer Contracts, currently requires the contracting officer to withhold 10% of the amounts due on each voucher: however, payment may be made in full during any month in which the contracting officer determines the performance to be satisfactory. The Government retains the withhold amount until the contracting officer determines that the work has been satisfactorily completed. The contracting officer may release excess withhold amounts to the contractor when it is determined that work is substantially complete and when the contracting officer determines that the amount retained is in excess of the amount adequate for the protection of the Governments interests.

This rule proposes to revise FAR 52.232-10 to permit contracting officers to use their judgment regarding the amount of payment withhold to apply under fixed-price architecture-engineer contracts (based on an assessment of the contractor's performance under the contract) so that the withhold amount will be applied at the level necessary to protect the Government's interests. This is in contrast to the current requirement that contracting officers withhold 10 percent on all payments. Thus, the rule proposes to revise paragraphs (b) and (c) of the contract clause at FAR 52.232-10 to state that the contracting officer may (rather than shall) withhold up to 10 percent of the payment amount due and that the amount of withhold shall be determined based upon the contractor's performance record. The rule also makes several related editorial changes including one that clarifies that the contractor will be paid any unpaid balance due to include withhold

amounts at the successful completion of the design work.

This case originated from a recommendation in the Small Business Administration's Regulatory Review and Reform (r3) initiative. The current withholding provisions negatively impact the cash flow of architectengineer contractors and may, in some instances, result in the withholding of amounts that exceed reasonable amounts to protect the Government's interests.

This is not a significant regulatory action and, therefore, is not subject to review under Section 6(b) of Executive Order 12866, Regulatory Planning and Review, dated September 30, 1933. This rule is not a major rule under 5 U.S.C. 804.

B. Regulatory Flexibility Act

The Councils do not expect this proposed rule to have a significant economic impact on a substantial number of small entities within the meaning of the Regulatory Flexibility Act, at 5 U.S.C. 601, et seq., because the rule does not impose any additional requirements on small businesses. There are approximately 230,000 architectengineer firms, many of which are small businesses. This rule actually eases the impact on such firms. Therefore, an Initial Regulatory Flexibility Analysis has not been performed. We invite comments from small businesses and other interested parties. The Councils will consider comments from small entities concerning the affected FAR Part 52 in accordance with 5 U.S.C. 610. Interested parties must submit such comments separately and should cite 5 U.S.C. 601, \hat{et} seq. (FAR Case 2008–015) in correspondence.

C. Paperwork Reduction Act

The Paperwork Reduction Act does not apply because the proposed changes to the FAR do not impose information collection requirements that require the approval of the Office of Management and Budget under 44 U.S.C. 3501, et seq.
