DEKALB COUNTY BOARD RECORD OF LOCAL SITING PROCEEDINGS

On June 21, 2010, the Illinois Pollution Control Board ("Board") issued an order accepting to petitions contesting the DeKalb County Board's ("the County") decision to grant WMII's application for local siting subject to conditions. On its own motion, the Board consolidated the petition of Stop the Mega-Dump ("STMD") (PCB 10-103) and the petition of Waste Management of Illinois, Inc. ("WMII") (PCB 10-104) for the purposes of hearing. The June 21, 2010 Board order also directed the County to file the record of proceedings ("Record") within 21 days, or by July 8, 2010. On July 1, 2010, WMII filed a motion to sever these two consolidated appeals. On July 2, 2010, the County moved for leave to file a reduced number of copies of the Record. On July 20, 2010, the County filed an original and two discs containing electronic copies of Record in the consolidated dockets. On August 19, 2010, the Board granted WMII's motion to sever the proceedings. Hearing Officer Halloran then granted the County's motion to file a reduced number of copies in part and denied it in part. Hearing Officer Halloran directed the County to file an additional hard copy in docket PCB 10-103 and an original, and one hard copy in docket PCB 10-104, in order to complete the record in both dockets for purposes of appeal.

WHEREFORE, the DeKalb County Board files an original and one hard copy of the DeKalb County Board Record of Proceedings, together with the certification of the Record in the above-captioned proceeding.
