
**HEARING OFFICER ORDER**

On September 9, 2010, all parties participated in a telephonic status conference with the hearing officer. The respondent represented that discovery is proceeding and that a deposition has been taken of complainant's expert witness. Respondent anticipates taking complainant's deposition as well. Respondent also anticipates that it will be filing a motion for summary judgment in an attempt to alleviate the necessity of a hearing.

As noted in the last order, complainant expressed his dissatisfaction of government agencies, including all lawyers.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on October 14, 2010, at 9:30 a.m. The status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




