

**HEARING OFFICER ORDER**

On September 23, 2010, the petitioners informed the hearing officer that a permit has been issued in a related permit appeal and will serve as a model for this appeal. The petitioners stated that they will file an additional 60-day waiver of the statutory decision deadline.

IT IS SO ORDERED.




