Dear Sir/Madam:

I am writing regarding Waste Management's proposal to expand the DeKalb County Landfill. I vigorously oppose the DeKalb County Board's vote to approve the expansion.

First, I am very concerned about the health and environmental risks of the current landfill, which would be exacerbated by the potential expansion. Hydrogen Sulfide gas has been detected at the new Cortland Elementary School in the vicinity of the landfill off of Rt. 38. Granted, the current landfill was there first, but unknown levels of toxic gas threaten the health of students, staff, and nearby residents. There is no "safe" level of H₂S, and it can only get worse with the additional trash from 17 other counties, which would be ten times the amount deposited there now. Toxic emissions and possible groundwater contamination jeopardize the well-being of present and future citizens and wildlife in the area. Additional traffic from waste haulers will also contribute to more pollution, as well as extra wear and tear on our roads.

The process for approval of this project was also highly suspect. The County Board granted Waste Management's proposal despite considerable opposition from DeKalb County residents. Indeed, much of the legwork was completed before we were even aware of the situation, including a deal with the village of Cortland. When the public was notified of the proposed expansion, we could not speak with Board members because they were also the jury! As elected representatives, they must listen and be accountable to their constituents, but they were forbidden to hear our complaints or answer our questions. This arrangement is intolerable, and while apparently legal, their vote completely disregards the wishes of the community. Moreover, they appear to be counting on "tipping fees" to pay for a county jail expansion, which the voters also defeated. Basically, this County Board sold out our health and that of future generations for some extra cash.

The DeKalb County Landfill may need to be expanded for the DeKalb County residents in the near future, but we do not want or need the garbage from 17 other counties in Illinois. There are already health and environmental hazards with the existing landfill. More information is needed to fully gauge its impact. Please reverse the Board's decision until other options are explored and more evidence is gathered. Thank-you.
