
**HEARING OFFICER ORDER**

On November 17, 2010, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that it will file an additional 15 day waiver of the statutory decision deadline while internal discussions continue on how to proceed with the above-captioned siting appeal.

Also discussed was respondent's motion to file a reduced number of the record, filed September 22, 2010. The petitioner had no objection to the motion. Respondent's motion was granted to the extent that respondent must file the original, two copies and 3 electronic copies of the record of the proceedings. Respondent filed the appropriate number of the record on November 4, 2010.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on December 1, 2010, at 10:00 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


