MOTION FOR LEAVE TO FILE REDUCED NUMBER OF COPIES OF RECORD

NOW COMES, Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, *ex rel.* Lisa Madigan, Attorney General of the State of Illinois, and moves for leave to file a reduced number of paper copies of the record for the subject permit, and states as follows:

1. Section 101.302(h) of the Board's Procedural Rules, 35 Ill. Adm. Code 101.302 (h), provides that the Illinois EPA is to file an original and 9 duplicate copies of the record of decision.

2. Duplication of the record would be time consuming and a strain on State resources. Respondent respectfully requests that the Board waive strict application of Rule 101.302(h), and allow it to satisfy a portion of the filing requirement with CD Disks containing Illinois EPA's record of determination for the permit at issue.

3. Communication with the Clerk's office indicates that the Board may be agreeable to accepting an original and two hard copies along with 3 CD disks, in lieu of the required original and nine hard copies.

Respondent respectfully requests leave to file a reduced number of copies, that being an
original and two hard copies along with 3 CD disks, of Illinois EPA's record of decision
in this matter.




