## MOTION FOR VOLUNTARY DISMISSAL

- 1. On or about January 5, 2009, PRN and Sierra Club filed a Petition for Review of a December 2, 2008 decision by the Illinois Environmental Protection Agency ("Illinois EPA" or "IEPA") before the Illinois Pollution Control Board (the "IPCB") in Docket No. PCB R09-46 ("Sugar Camp Petition for Review"), in which it sought review of the Illinois EPA's decision to grant a new National Pollutant Discharge Elimination System ("NPDES") Permit, Permit No. IL0078565, to Sugar Camp for its mine to discharge mine drainage, reclamation area drainage and stormwater runoff.
