

**HEARING OFFICER ORDER**

On December 21, 2010, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that based on respondent's representations, it appears the site is now remediated. The complainant anticipates that the inspector will visit the site and in the interim, complainant will draft a stipulation and proposal for settlement (stipulation) for respondent's review. and that a settlement will be discussed.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on February 24, 2011, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the status conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further notice.

IT IS SO ORDERED.




