### JOINT MOTION TO CANCEL HEARING

NOW COME Petitioner, KCBX TERMINALS COMPANY, a North Dakota corporation, by and through its attorneys, HODGE DWYER & DRIVER, and Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, by and through its attorneys, and pursuant to 35 Ill. Admin. Code § 101.510, hereby jointly move that the Hearing Officer cancel the hearing in the above-referenced consolidated matters set for June 1 and 2, 2011.

- 1. The parties have recently discussed the potential for a negotiated settlement on the contested conditions at issue in these matters. And, in order for the parties to engage in settlement negotiations in these matters, a meeting has been scheduled for June 1, 2011, in Springfield, to continue to June 2, 2011, as necessary.
- Therefore, the hearing originally scheduled in these matters for June 1 and
   2, 2011, should be cancelled.
- The parties intend to update the Hearing Officer as to the status of the settlement negotiations during the telephone status conference scheduled for June 2,
   At that time, the parties will be in a position to better determine whether it will be
