


Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, in accordance with the procedural rules of the Illinois Pollution Control Board as set forth in 35 Ill. Adm. Code 105.212 and 105.116, hereby files one signed original and four copies of the Illinois EPA's record for the renewal of Geneseo Municipal Utilities' ("Geneseo") Federally Enforceable State Operating Permit ("FESOP") for IEPA Facility ID. No. 073050AAA, issued on April 6, 2011. The record of all information the Agency relied upon in making its final decision is attached and includes the following:

- 1) All documents within File No. 73090137, maintained by the Agency's Permit Section for the Geneseo facility, that the Agency consulted during the FESOP renewal process, in receding chronological order, which includes, but is not limited to:
 - a. the renewal application and transmittal letter that resulted in the Agency's final decision;
