
HEARING OFFICER ORDER

On September 8, 2011, a telephonic status conference was held. Respondent Zachary Isaac d/b/a Nu Shine Car Wash (NuShine) did not appear. The complainant stated that it and respondent Samuel Johnson (Johnson) have continued to have had productive discussions. Johnson will forward additional financial documents to the complainant for its review. By agreement, Johnson's answer is now due to be filed on or before November 25, 2011.

The complainant stated that it has infrequently talked to NuShine. It is noted that NuShine has yet to file an appearance or answer.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on November 15, 2011, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




