
HEARING OFFICER ORDER

On January 12, 2012, a telephonic status conference was held. Respondent Zachary Isaac d/b/a Nu Shine Car Wash (NuShine) did not appear. The complainant stated that it and respondent Samuel Johnson (Johnson) have apparently reached a settlement and a draft stipulation and proposal for settlement (stipulation) is being circulated for review. By agreement, Johnson's answer is now due to be filed on or before March 15, 2012.

The complainant stated that it will likely file a motion for default as to NuShine. It is again noted that NuShine has yet to file an appearance or answer.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on March 1, 2012, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference as to Johnson, Johnson will not have to appear.

IT IS SO ORDERED.




