**HEARING OFFICER ORDER**

On April 12, 2012, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that its motion to dismiss the Illinois Department of Transportation filed on March 30, 2012, may have a service issue and it will re-file.

The parties represented that settlement discussions are scheduled for May 2012. By agreement, the discovery cut-off date is now June 15, 2012.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on May 24, 2012, at 11:45 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. The complainant represented that it will notify the parties and the hearing officer of a call-in number prior to the next telephonic status conference. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.



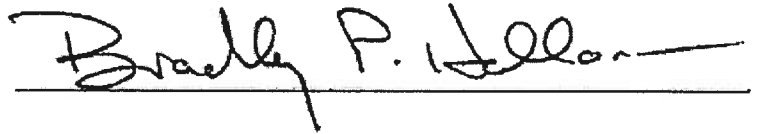
